  - b) The City Engineer is authorized to close the portion of the street herein described at any time during the period specified provided the provisions of the Municipal Act, R.S.O. 1970, Chapter 284, Sec. 352, Par. 60 are complied with.
- 2. The provisions of the Municipal Act R.S.O. 1970, Chapter 284, Section 352, Paragraph 60 shall apply to the portion of the Highway closed by this by-law.
