THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 8-87

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT WITH THE NORTH BAY AND DISTRICT HEALTH CENTRE.

WHEREAS the City of North Bay Act, 1986 authorizes the Council to pass by-laws respecting funding for the North Bay and District Health Centre.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That The Corporation of the City of North Bay do enter into that certain agreement dated August 18th, 1986 between the North Bay and District Health Centre and The Corporation of the City of North Bay relating to the funding for the North Bay and District Health Centre.
- 2. That the Mayor and Clerk be and they are hereby authorized and empowered to execute the aforesaid agreement dated August 18th, 1986 on behalf of The Corporation of the City of North Bay and to affix thereto the corporate seal.
- 3. This by-law shall not come into force and effect until the approval of the Ontario Municipal Board has been received.
