BY-LAW NO. 128-97

**BEING A BY-LAW TO AMEND TRAFFIC BY-LAW
NO. 131-93, SCHEDULE 5 (NO PARKING - RESTRICTED TIMES);
SCHEDULE 6 (PARKING PROHIBITED FOR RESTRICTED PERIODS);
SCHEDULE 2 (NO PARKING ANY TIME); SCHEDULE 20 (TRAFFIC
CONTROL SIGNALS)**

WHEREAS the Municipal Act, R.S.O. 1990, Chapter M-45 authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways.

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1.	Cassells Street	Both	Percy & Third Avd.	1 hour

3. Schedule 6 of Traffic By-law No. 131-93 is hereby amended by deleting the following:

	<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>	<u>PROHIBITED</u>
1.	McLaren Street	North	Bloem St. & 142 metres easterly	8:00 a.m. -8:00 p.m.

4. Schedule 2 of Traffic By-law No. 131-93 is hereby amended by adding the following:

	<u>SECTION M</u> <u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
1.	McLaren Street	South	Durrill Street to Bloem Street
2.	McLaren Street	North	Bloem Street to 142 metres easterly
3.	McLaren Street	North	Algonquin Avenue and 213 metres westerly

5. Schedule 20 to Traffic By-law No. 131-93 is hereby amended by adding the following:

McIntyre Street East and John Street


Connaught Avenue and Trout Lake Road


Marshall Park Drive and Lakeshore Drive
