

BY-LAW NO. 1173

BEING A BY-LAW to fix the Polling Places and appoint Deputy Returning Officers for the holding of Municipal Elections for the year 1935, in the Municipality of North Bay.

WHEREAS it is necessary to pass a By-Law fixing Polling Places and appointing Deputy Returning Officers for the purpose of taking the vote of the Electors, to select a Mayor and Ten (10) Aldermen (Two (2) for each Ward) to transact the Municipal affairs of the City, for the selection of Public School Trustees (One (1) for each Ward), on the question of abolishing the Ward System for Municipal elections.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

- (1) THAT Polling Place No. 1 for the purpose of the said election shall be in W. Santary's Store, 382 Main Street West, and G. L. Riches and T. H. Winters are hereby appointed Deputy Returning Officers.
- (2) THAT Polling Place No. 2 for the purpose of the said election shall be in the Court House, Bye and McIntyre Streets and D. J. Quinn and R. J. Peel are hereby appointed Deputy Returning Officers.
- (3) THAT Polling Place No. 3 for the purpose of said election shall be in Jas. Palangio's store, 38 Front Street, and G. Elmitt, C. J. O'Grady and Robt. Colbon are hereby appointed Deputy Returning Officers.
- (4) THAT Polling Place No. 4 for the purpose of said election shall be in H. T. Relph's residence, 145 Worthington Street West, and W. Foster and H. T. Relph are hereby appointed Deputy Returning Officers.
- (5) THAT Polling Place No. 5 for the purpose of said election shall be in the City Hall, McIntyre and Ferguson Streets, and W. Childerhose and E. B. Willis are hereby appointed Deputy Returning Officers.
- (6) THAT Polling Place No. 6 for the purpose of said election shall be in the Canadian Legion Club Rooms, McIntyre and Ferguson Streets, and S. G. Stewart and J. E. Lehman are hereby appointed Deputy Returning Officers.
- (7) THAT Polling Place No. 7 for the purpose of said election shall be in the Orange Hall, Fisher and McIntyre Streets, and G. H. Newton and L. Thacker are hereby appointed Deputy Returning Officers.
- (8) THAT Polling Place No. 8 for the purpose of said election shall be in the Orange Hall, Fisher and McIntyre Streets, and D. King and H. R. Miller are hereby appointed Deputy Returning Officers.
- (9) THAT Polling Place No. 9 for the purpose of said election shall be at A. Orfankos's Store, 307 McIntyre Street East, and H. W. Sharpe and Jas. Mellis are hereby appointed Deputy Returning Officers.
- (10) THAT Polling Place No. 10 for the purpose of said election shall be at C. J. Corbett's residence, 215 Fisher Street, and J. M. White, Aurele Aubrey and Alex Smith are hereby appointed Deputy Returning Officers.
- (11) THAT Polling Place No. 11 for the purpose of said election shall be at the Orange Hall, Cassells Street, between Third Avenue and Percy Street, and E. J. Carter, P. W. White and A. S. Waite are hereby appointed Deputy Returning Officers.

- (12) THAT Polling Place No. 12 for the purpose of said election shall be at E. M. Drury's Residence, 111 Front Street, and Ed. Everitt and S. J. Chamberlain are hereby appointed Deputy Returning Officers.
- (13) THAT Polling Place No. 13 for the purpose of said election shall be in E. C. Bebee's residence, 399 Cassell St., and A. Miller and E. C. Bebee are hereby appointed Deputy Returning Officers.
- (14) THAT the Railway Employees, Express Messengers and Commercial Travellers Advance Polling Place for the purpose of said election shall be in the City Hall, Ferguson and McIntyre Streets, and A. C. Amos is hereby appointed Deputy Returning Officer.
- (15) THAT the City Clerk shall attend the Council Chambers at the hour of Twelve Noon on the 4th. day of December, A. D. 1934 for the final summing up of the number of votes for the Mayor and Aldermen and to sum up the votes for and against the above mentioned question.
- (16) THAT the Mayor of the said Municipality or some other member of Council appointed by resolution shall attend at the City Hall on the 26th. day of November, A. D. 1934 of the said Municipality for the purpose of appointing and if requested to do so shall appoint by writing signed by him, two persons to attend at the final summing up of the votes by the Clerk, and one person to attend at each polling place on behalf of the persons interested in and voting in the affirmative on said question and a like number on behalf of the persons interested in and voting in the negative on said question. The votes on the said question shall be taken on Monday, the 3rd. day of December, 1934, and at the same time and at the same place and with the same Deputy Returning Officers as for the election of Mayor and Aldermen for the City of North Bay, for the year 1935.

Read a Second Time in Open Council this 5th day of November, 1934.

Rules of Order were suspended and By-Law was read a Third Time short and passed this 5th day of November, 1934.
