

BY-LAW NO. 2116

BEING A BY-LAW to amend or repeal certain sections or all of By-law 2015, a by-law amending By-law 1779.

WHEREAS it is deemed necessary to authorize and provide for certain Department Heads and Secondary Heads who are not covered by Union Agreement such as the Deputy Welfare Administrator, the Deputy Tax Collector and the Deputy Inspector of Buildings, of Plumbing and the Construction Safety Act, and;

WHEREAS by Clause 1 of the Committee of the Whole report adopted by City Council on May 14th 1963 the effect and intent was formally approved by a resolution of the City Council, and;

WHEREAS it is necessary to make such provisions by by-law,

NOW THEREFORE THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That By-law No. 2015 be repealed as it applies to Assistant Welfare Administrator.
2. That By-law No. 1779 be amended to provide for the following:-

Deputy Building, Plumbing and Construction Safety Inspector	4325.00	225.00	5450.00


3. That Mr. Percy King, formerly Assistant Tax Collector, be the Deputy Tax Collector and that his starting salary be \$4775.00 per year being the third year increment, effective July 1st 1963.
4. That Mr. Robert F. Barton be the Deputy Welfare Administrator at a starting salary of \$4325.00 per year, effective July 1st 1963.
5. That Mr. William C. Raycraft, former Assistant Welfare Administrator, be appointed as Deputy Building, Plumbing and Construction Safety Inspector at a starting salary of \$4325.00 per year, effective July 1st 1963.
6. That Mr. R. Lassman, Building Inspector, be appointed in addition thereto as Plumbing and Construction Safety Inspector, effective July 1st 1963.
7. That By-laws No. 2015 and No. 1779 and all other prior by-laws inconsistent with this by-law are hereby repealed.
