

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 45-95

BEING A BY-LAW TO AMEND
BY-LAW NO. 21-72 BEING A
BY-LAW TO ESTABLISH AN
AREA FOR THE COLLECTION,
REMOVAL, AND DISPOSAL OF
GARBAGE, AS AMENDED BY
BY-LAW NO. 24-77, NO. 89-77,
NO. 82-78, AND NO. 212-86.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "A" to By-Law No. 212-86 be amended to include, for the collection of garbage, all of Lots 20 and 21 of Concessions V and VI, in the former Township of Widdifield so that the said Schedule "A" shall read as Schedule "A" attached hereto and forming part of this By-Law.

THIS IS SCHEDULE "A" TO BY-LAW NO. 45-95 OF THE CORPORATION OF THE CITY OF NORTH BAY

Commencing at a point where the southeasterly corner of Lot 25, Concession 11 intersects the boundary between the City of North Bay and the Township of North Himsworth;

Thence in a generally southwesterly direction along the boundary between the City of North Bay and the Township of North Himsworth to a point where the said boundary intersects the shoreline of Lake Nipissing;

Thence in a generally northwesterly direction along the shoreline of Lake Nipissing to a point where the shoreline of Lake Nipissing intersects the boundary between the City of North Bay and the Township of Commanda;

Thence northerly along the boundary between the City of North Bay and the Township of Commanda to the northwesterly corner of Lot 24, Concession IV;

Thence easterly along the line between Concessions IV and V to the line between Lots 21 and 20, Concession V;

Thence northerly along the line between Lots 21 and 20, Concession V to the line between Lots 21 and 20 at the northerly limit of Concession VI;

Thence easterly along the northerly boundary of Lots 21 and 20, Concession VI to the line between Lots 20 and 19, Concession VI;

Thence southerly along the line between Lots 20 and 19, Concessions VI and V to the line between Lots 20 and 19, Concession IV;

Thence easterly along the line between Concessions IV and V to the line between Lots 17 and 18, Concession IV;

Thence southerly along the line between Lots 17 and 18 to the line between Concessions A and I;

Thence easterly along the line between Concessions A and I to a point where the line intersects the line between Lots 16 and 17;

Thence southerly along the line between Lots 16 and 17 to a point 150 feet north of the line between Concessions A and B;

Thence easterly and parallel to the line between Concessions A and B to the line between Lots 11 and 12 being 150 feet north of the line between Concessions A and B;

Thence southerly along the line between Lots 11 and 12 to a point 500 feet north of the line between Concessions B and C;

Thence easterly in a straight line and parallel to the line between Concessions B and C to the line between Lots 9 and 10;

Thence southerly along the line between Lots 9 and 10 to a point where the line between Lots 9 and 10 intersects the shoreline of Lounsbury Bay;

Thence in a generally south southwesterly direction and following the sinuosities of the shoreline of Trout Lake to a point where the said shoreline intersects the boundary between the City of North Bay and the Township of East Ferris;

Thence southeasterly along the said boundary between the City of North Bay and the Township of East Ferris to the point of commencement.
