

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 104-68

BEING A BY-LAW TO EXPROPRIATE THE LANDS  
AND PREMISES HEREINAFTER MORE PARTICULARLY  
DESCRIBED FOR PARK PURPOSES

WHEREAS it is necessary to expropriate the lands and  
premises hereinafter more particularly described for park pur-  
poses:

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF  
NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the lands and premises hereinafter more particularly  
described be expropriated and taken for park purposes:

DESCRIPTION OF LANDS AND PREMISES

All and singular those certain parcels or tracts of lands and  
premises situate, lying and being in the City of North Bay, in  
the District of Nipissing and Province of Ontario, being composed  
of:

Firstly, Lot 10 and the northerly 15' of Lot 9 according as  
the said lot is shown on Plan M-189 filed in the Office of Land  
Titles at North Bay.

Secondly, all of Lots 7 and 8 and the southerly 25' of Lot  
9 according as the said lots are shown on said plan filed in the  
Office of Land Titles at North Bay as plan M-189.

Thirdly, all of Lots 193 and 194 according as the said lots  
are shown on a plan filed in the Registry Office for the Registry  
Division of the District of Nipissing as Plan No. 93.

Fourthly, Lot 192 according as the said lot is shown on a  
plan filed in the Registry Office for the Registry Division of  
the District of Nipissing as Plan No. 93.


Fifthly, Lots 311 and 312 according as the said lots are  
shown on a plan filed in the Registry Office for the Registry  
Division of the District of Nipissing as Plan No. 93.

2. That the Mayor and Clerk of the Corporation of the City of  
North Bay be and they are hereby authorized and empowered to  
execute the within By-law on behalf of The Corporation of the  
City of North Bay and any necessary plans, including the linen  
copy thereof to be registered in accordance with the provisions  
of the Expropriation Procedures Act, Chapter 42, Statutes of  
Ontario 1962-63 as amended to date.

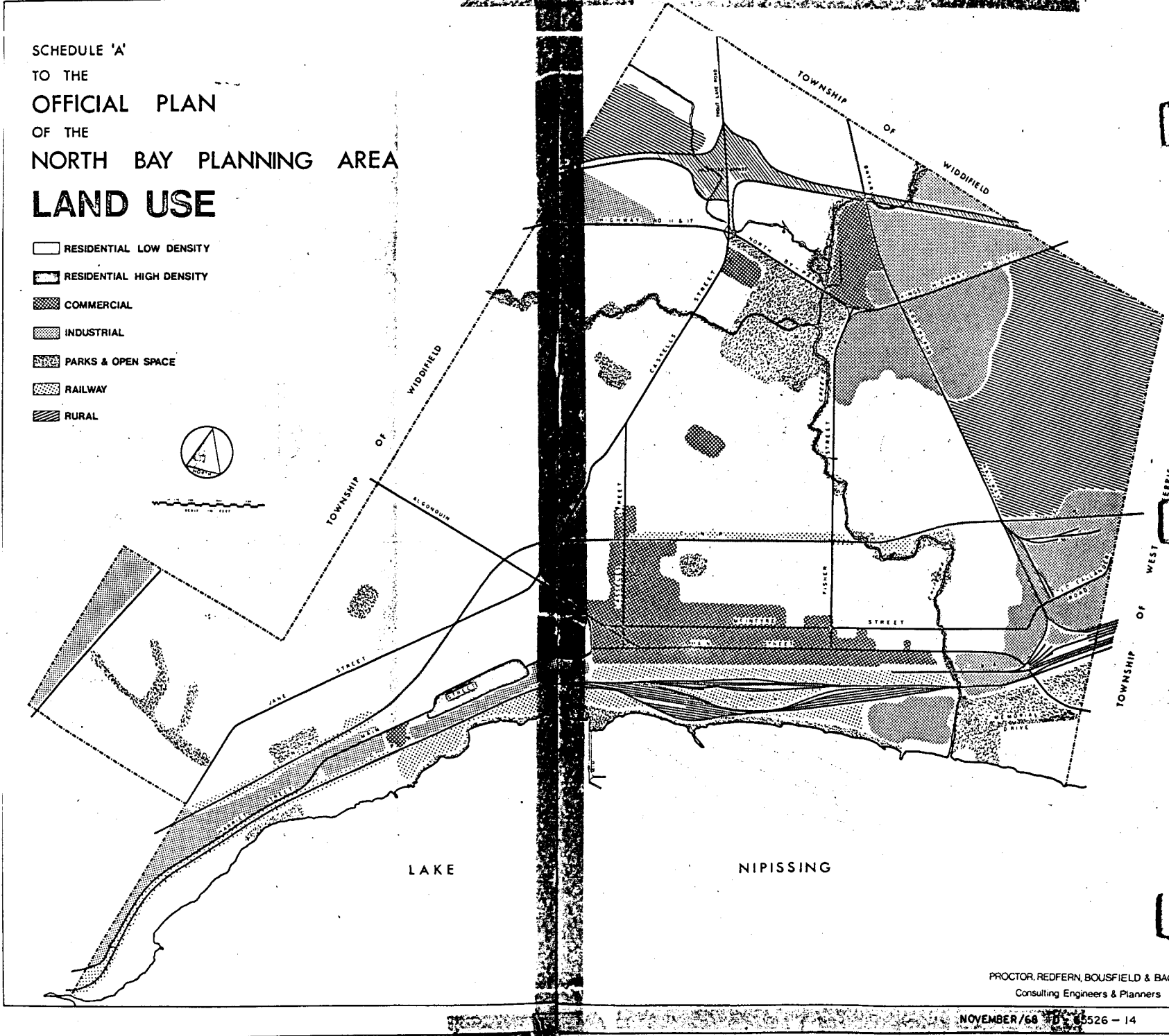
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED
