

BY-LAW NO. 2202

BEING A BY-LAW authorizing the entering into of an agreement with the Corporation of the Township of Widdifield and the Corporation of the Township of West Ferris to establish a committee to conduct urban and regional research throughout the boundaries of the parties to the said agreement.

WHEREAS it is expedient to enter into the agreement attached hereto and marked Schedule "A" to this by-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That the Corporation of the City of North Bay do enter into the agreement attached hereto and marked Schedule "A" to this By-law upon and subject to the terms and conditions therein set forth and that the Mayor and Clerk be and they are hereby authorized to execute the said agreement on behalf of the Corporation of the City of North Bay and to affix thereto the corporate seal.

MEMORANDUM OF AGREEMENT MADE THIS day of A.D. 1965.

B E T W E E N :

THE CORPORATION OF THE CITY OF NORTH BAY

OF THE FIRST PART:

THE CORPORATION OF THE TOWNSHIP OF WIDDIFIELD

OF THE SECOND PART:

THE CORPORATION OF THE TOWNSHIP OF WEST FERRIS

OF THE THIRD PART:

WHEREAS the parties hereto deem it to be to their mutual benefit to create a committee to conduct urban and regional research throughout the boundaries of the parties hereto:

AND WHEREAS the Canadian Council of Urban and Regional Research has requested the parties hereto to set up a Committee for the said purposes and has indicated that such a Committee would be eligible for grants to carry on the proposed project:

NOW THEREFORE THE PARTIES HERETO MUTUALLY AGREE EACH WITH THE OTHERS AS FOLLOWS:

- (1) That a Committee be created to be known as THE METRO NORTH BAY DEPARTMENT OF INDUSTRIES MUNICIPAL COMMITTEE ON URBAN AND REGIONAL RESEARCH, hereinafter referred to as "the Committee".
- (2) That the Committee be composed of the Directorate of North Bay, Widdifield, West Ferris Department of Industries.
- (3) The Committee at its first meeting in each year
 - (a) will elect from the appointees of the parties hereto a Chairman, to hold office during the calendar year and until his successor is elected;
 - (b) will appoint a Secretary and a Treasurer to hold office at the pleasure of the Committee.
- (4) A quorum of the Committee shall be a majority of the members thereof.
- (5) The Committee is empowered to receive grants of money for the furtherance of its objects and shall be empowered to expend any moneys so received toward the furtherance of its objects, but under

no circumstances shall the Committee be authorized or empowered to commit or pledge the credit of any of the parties hereto.

(6) The Committee shall submit a written report of its activities with an itemized statement of all receipts and disbursements to each of the parties hereto on or before the 10th day of January in each year covering its activities, during the preceding calendar year.
