BY-LAW NO. 223-90

BEING A BY-LAW TO AMEND BY-LAW NO. 229-89 BEING A BY-LAW TO AUTHORIZE CONSTRUCTION OF A SANITARY SEWER ON ROSE AVENUE AND A WATERMAIN ON MACDONALD AVENUE WEST FROM CAMPBELL AVENUE.

WHEREAS Council deems it desirable to increase the net debentured cost to \$72,350.00 as approved in By-Law No. 229-89.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule A attached to and forming part of By-Law No. 229-89 be deleted and the Schedule A attached hereto and forming part of this By-Law be attached in lieu thereof.

READ A FIRST TIME IN OPEN COUNCIL THE 26TH DAY OF NOVEMBER, 1990.

READ A SECOND TIME IN OPEN COUNCIL THE 26TH DAY OF NOVEMBER 1990.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 29TH DAY OF APRIL, 1991.


