

BY-LAW 1519

A BY-LAW TO AUTHORIZE A COMMUNITY PROGRAMME UNDER THE REGULATIONS REGARDING PHYSICAL FITNESS AND RECREATION PURSUANT TO THE DEPARTMENT OF EDUCATION.

WHEREAS the Municipal Act R.S.O. 1937, Chapter 266, Section 404 s. s. 2a authorizes the councils of all municipalities to pass by-laws for carrying on a community programme of training in physical fitness within the meaning of the regulations under the Department of Education Act.

AND WHEREAS the Minister of Education is empowered to make certain regulations under the Department of Education Act.

AND WHEREAS the Minister of Education has made certain regulations regarding physical fitness and recreation under the said act and the said regulations have been approved by Order-in-Council and published in the Ontario Gazette.

AND WHEREAS it is deemed advisable to adopt a community programme as set out in the said regulations.

THEREFORE THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. That a community programme of training in physical fitness and recreation of persons in the community shall be carried on in the City of North Bay.

2. A local Committee to be known as the North Bay Recreational Council (and which is hereinafter referred to as "The Recreational Council"), is hereby constituted, the members of such Recreational Council to be such persons as are from time to time appointed as members thereof by the Council of the City of North Bay by resolution.

3. The duties of the Recreational Council shall be to carry on in the City of North Bay a community programme of training in physical fitness and recreation of persons in the community and without limiting the generality of the foregoing the Recreational Council is authorized and empowered;-

(a) To appoint officers from amongst its members, to enact by-laws for its own government, and to alter, modify, repeal and re-enact the same.

(b) To hire, pay and discharge staff, and to fix their duties and responsibilities.

(c) To purchase, hire, make or provide, and to re-sell or dispose of furniture, furnishings, fixtures, sports, recreational entertainment equipment necessary to achieve the objects of the Recreational Council.

(d) To take any gifts of property in conformity with the objects of the Recreational Council.

(e) Any funds coming into the hands of the Council for Recreational purposes, shall be held by the Treasurer of the City of North Bay and paid out by him only with the approval of the Recreational Council on voucher signed by the Chairman, or the Secretary and the Director of the Council.

(f) To apply for and receive financial assistance from any government or other authority.

(g) To enter into contracts in its own name for the purpose of its business.

(h) To print and publish any paper, periodical, book or leaflet it may deem desirable for the promotion of its objects and to advertise its affairs, activities and undertakings by any means it may be thought advisable.

(i) To do all such other lawful things as are incidental or conducive to the achievement of its objects.

4. Notwithstanding anything to the contrary hereinbefore contained, all by-laws, rules and regulations of the Recreational Council shall be subject to the approval of the Council of the City of North Bay.

5. All voting on motions shall be by show of hands, and any member may call for a recount of votes immediately after the result has been announced.

6. In carrying out the provisions of this By-Law the Recreational Council shall at all times be agent of the Municipal Corporation of the City of North Bay and while acting bona fide within the limits of the authority of this by-law, neither the Recreational Council nor any member thereof shall incur any liability by reason of anything done or left undone by the Recreational Council; provided however, that nothing in this paragraph contained shall authorize or empower the Recreational Council to incur any debt, liability or obligation for which the Municipal Corporation of the City of North Bay shall become liable without having previously obtained the consent of the Council of the Corporation of North Bay.

7. This by-law shall come into force and take effect on the day of the final passing.
