

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 2388

A By-law to authorize an application to The Ontario Municipal Board for an Order annexing part of the Township of West Ferris.

WHEREAS by Section 14 (2) of The Municipal Act, R.S.O. 1960, Chapter 249, it is provided in part that upon the application of any municipality authorized by by-law of the Council thereof, The Ontario Municipal Board may be Order, on such terms as it may deem expedient, annex the whole or any part or parts of any other municipality or municipalities to the municipality;

AND WHEREAS the Council of the Corporation of the City of North Bay deems it expedient to apply to The Ontario Municipal Board for an Order annexing that part of the TOWNSHIP OF WEST FERRIS more particularly described in Schedule "A" attached to and forming part of this By-law;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

(1) THAT an application by The Corporation of the City of North Bay to The Ontario Municipal Board for an Order annexing to The Corporation of the City of North Bay those parts of the TOWNSHIP OF WEST FERRIS more particularly described in Schedule "A" hereto annexed, be and the same is hereby authorized.

(2) THAT the said SCHEDULE "A" hereto annexed is hereby declared to be part of this By-law in the same manner as if written and incorporated herein.



## SCHEDULE "A"

ATTACHED TO AND FORMING PART OF BY-LAW NO. 2388 OF THE  
CORPORATION OF THE CITY OF NORTH BAY

---

ALL AND SINGULAR those certain parcels or tracts of lands and premises, situate, lying and being in the Township of West Ferris, in the District of Nipissing, and being composed of those parts of the said Township bounded as follows:

COMMENCING at a point where the boundary between the City of North Bay and the Township of West Ferris intersects Lake Nipissing;

THENCE easterly along the said boundary to the easterly boundary of the said Township;

THENCE southerly along the said easterly boundary to a point two hundred feet (200') south of and perpendicular to the right-of-way of Provincial Highway No. 17 (known as the Trans-Canada Highway);

THENCE westerly along a line two hundred feet (200') south of and parallel to the said Provincial Highway No. 17 to the centre line of Provincial Highway No. 11;

THENCE southerly along the said centre line of said Provincial Highway No. 11 to a point two hundred feet (200') south of the road allowance between Concessions 12 and 13;

THENCE westerly parallel to the said road allowance to the centre of LaVase River;

THENCE southwesterly along the centre line of the said River to the boundary between Lots 38 and 39;

THENCE southerly along the boundary between the said Lots, to the boundary between Concessions 11 and 12;

THENCE westerly along the said boundary line to Lake Nipissing, and

THENCE northerly along Lake Nipissing to the point of commencement;

ALONG WITH that area enclosed by the following boundaries:

SCHEDULE "A"

COMMENCING at a point where the boundary between the City of North Bay and the Township of West Ferris intersects the high water mark of Lake Nipissing,

THENCE South  $69^{\circ} 08' 20''$  West along the south-westerly production of the said boundary line a distance of 10,980 feet more or less to its intersection with the southerly production of the west boundary of the Geographic Township of Widdifield;

THENCE due south along the southerly production of the said west boundary of the Geographic Township of Widdifield a distance of 6,600 feet to a point in the centre line of Lake Nipissing;

THENCE South  $38^{\circ} 00'$  East to a point which would be intersected by the westerly production of the boundary between Concessions 11 and 12 of the Township of West Ferris;

THENCE in an easterly direction along the said westerly production to the high water mark of Lake Nipissing;

THENCE northwesterly along the said high water mark of Lake Nipissing to the point of commencement.
