BY-LAW NO. 37-70

BEING A BY-LAW to appoint and designate members of the police force of the Corporation of the City of North Bay as officers to enforce within the Corporation of the City of North Bay The Liquor Licence Act and the regulations thereunder and The Liquor Control Act and the regulations thereunder.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


- (1) THAT the members of the police force of The Corporation of the City of North Bay named in Schedule "A" attached hereto and forming part of this By-law be and are hereby appointed and designated as officers to enforce within the Corporation of The City of North Bay The Liquor Licence Act, The Liquor Control Act and the regulations thereunder respectively.
- (2) THAT By-law No. 2249 and all other By-laws of The Corporation of the City of North Bay conflicting with the provisions of the By-law shall be deemed to be and they are hereby repealed.
