

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 116-77BEING A BY-LAW TO GIVE NAMES TO CERTAIN  
HIGHWAYS WITHIN THE CITY OF NORTH BAY

WHEREAS pursuant to the provisions of Paragraph 97 of Section 379 (1) of the Municipal Act, R.S.O. 1970, it is considered desirable to give names to certain highways within the City of North Bay.

NOW THEREFORE THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That names be given to the Highways as set out and described in Schedules "A" and "B" attached hereto and forming part of this by-law.
2. That this by-law shall take effect as of and from the day of final passing thereof.

READ A FIRST TIME IN OPEN COUNCIL THIS 27TH DAY OF SEPTEMBER, 1977.

READ A SECOND TIME IN OPEN COUNCIL THIS 11TH DAY OF OCTOBER, 1977.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 11TH DAY OF OCTOBER, 1977.

1-1 PENINSULA ROAD

Commencing at a point situate in south half of Lot 9, Concession "B", Township of Widdifield and its intersection with Highway #63, thence southerly traversing Lots 2 to 9, Concession "C" in the Township of Widdifield for a total distance of 4.7 miles terminating at a point situate in the south half of Lot 2, Concession "C", Township of Widdifield, further shown on plan as Schedule "B" of this By-law, shall be known as Peninsula Road.

2-2 NORTHSHORE ROAD

Commencing at a point situate in the south half of Lot 8, Concession "B", Township of Widdifield and its intersection with Peninsual Road; thence in an easterly direction traversing Lots 4 to 8, Concession "B" in the Township of Widdifield for a distance of 3.1 miles terminating at a point situated in the south half of Lot 4, Concession "B", Township of Widdifield, further shown on plan as Schedule "B" of this by-law, shall be known as Northshore Road.

3-3 VICEROY ROAD

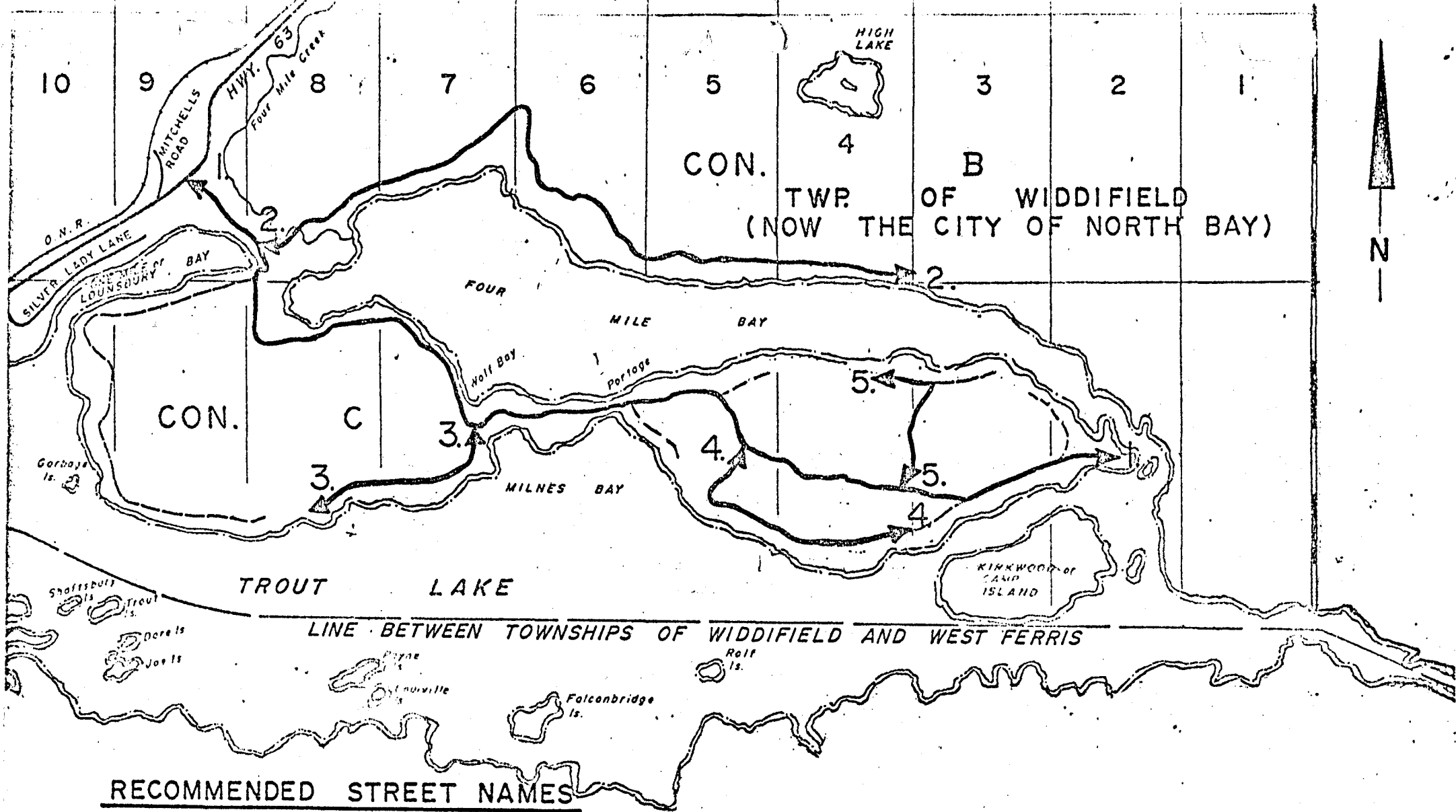
Commencing at a point situate in the north half of Lot 7, Concession "C" and its intersection with Peninsula Road; thence in a south and westerly direction traversing Lots 7 and 8, Concession "C" in the Township of Widdifield for a distance of 1.1 miles terminating at a point in the south half of Lot 8, Concession "C" in the Township of Widdifield, further shown on Plan as Schedule "B" of this by-law, shall be known as Viceroy Road.

4-4 REGAL ROAD

Commencing at a point situate in the south half of Lot 5, Concession "C", Township of Widdifield; thence in a south and easterly direction traversing Lots 4 and 5, Concession "C" for a distance of 1.1 miles terminating at a point in the south half of Lot, 4, Concession "C" Township of Widdifield, further shown on plan as Schedule "B" of this by-law shall be known as Regal Road.

5-5 SHOREWOOD ROAD

Commencing at a point situate in the south half of Lot 4, Concession "C", Township of Widdifield; thence in a north and westerly direction traversing Lots 3 and 4, Concession "C" for a distance of 0.8 miles terminating at a point in the north half of Lot 4, Concession "B", Township of Widdifield, further shown on plan as Schedule "B" of this By-law shall be known as Shorewood Road.
