

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 104-89

BEING A BY-LAW TO STOP UP, AND CLOSE A PORTION  
OF HELEN STREET IN THE CITY OF NORTH BAY.

WHEREAS it is deemed expedient and in the interest of The Corporation of the City of North Bay those parts of the street hereinafter described be closed and stopped up;

AND WHEREAS notice of this By-Law was published once a week for four consecutive weeks in the North Bay Nugget, published in the City of North Bay;

AND WHEREAS no person has claimed that his lands will be prejudicially affected by the passing of this By-Law nor applied to be heard in person or by his counsel, solicitor or agent, by the Council of the said City or a Committee of said Council;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. That certain part of Helen Street shown on Registered Plan M-153 in the City of North Bay designated as Part 1, Plan 36R-8067 is hereby closed and stopped up.
2. That certain part of Helen Street shown on Registered Plan M-153 in the City of North Bay and designated as Part 2, Plan 36R-8067 is hereby closed and stopped up.
3. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the Helen Street road allowance, designated as Part 2, on the said reference plan to Edmund and Jennie Dolata, registered owners of Lot 141, Plan M-456, Remainder of Parcel 671 W/F.
4. That certain part of Helen Street shown on Registered Plan M-153 in the City of North Bay designated as Part 3, Plan 36R-8067 is hereby closed and stopped up.
5. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the Helen Street road allowance designated as Part 3 on the said reference plan to 391342 Ontario Limited, registered owners of Lots 31, 32 and 33, Plan M-162, Parcels 11635 W/F and 10434 W/F.
6. This By-Law comes into force and effect upon a certified copy of this By-Law being registered in the Land Registry Office for the District of Nipissing.
