

**THE CORPORATION OF THE CITY OF NORTH BAY**

**BY-LAW NO. 2002-122**

**BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 131-93, AS AMENDED  
SCHEDULE 6 (PARKING PROHIBITED FOR RESTRICTED PERIODS);  
SCHEDULE 21, ZONE 1 (PARKING METER ZONE 2 HOUR);  
SCHEDULE 21, ZONE 4 (PARKING METER ZONE 8 HOUR); AND  
SCHEDULE 22 (PENALTIES)**

**WHEREAS** the *Municipal Act*, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass By-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

**AND WHEREAS** the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

**AND WHEREAS** the amendments to Schedule 6 (Parking Prohibited for Restricted Periods), Schedule 21, Zone 1 (Parking Meter Zone 2 Hour) and Schedule 21, Zone 4 (Parking Meter Zone 8 Hour) were authorized by Council Resolution No. 2002-554 passed by Council at its Regular Meeting held on Monday, September 23, 2002;

**AND WHEREAS** the amendments to Schedule 22 (Penalties) were authorized by Clause No. 2 of General Government Committee Report No. 2002-10 passed by Council at its Regular Meeting held on Monday, July 8, 2002.

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:**

1. That Schedule 6 to Traffic By-law is hereby amended by adding the following for a six month trial period two-hour parking restriction, to be in effect from 8:00 a.m. to 4:00 p.m. only, and to apply from Monday to Friday only:

300 Block of Plouffe Street

400 Block of Plouffe Street

500 Block of Copland Street

600 Block of Copland Street

2. That Schedule 21, Zone 1 to Traffic By-law No. 131-93 is hereby amended by adding the following:

**TO**

McIntyre Street West

North

Foran Street

Plouffe Street

3. That Schedule 21, Zone 4 to Traffic By-law No. 131-93 is hereby amended by adding the following:

**ZONE # 4**

**EIGHT HOUR MAXIMUM PARKING TIME LIMIT**

**ROAD**

**SIDE**

**FROM**

**TO**

McIntyre Street West

South

Plouffe Street

Murray Street

4. That Schedule 22 to By-law No. 131-93 is hereby amended by inserting the following in lieu of the existing offence:

<u>DESCRIPTION OF OFFENCE</u>	<u>PROVISION CREATING OR DEFINING OFFENCE</u>	<u>VOLUNTARY PAYMENT PAYABLE WITHIN FIVE (5) DAYS</u>
Park at expired meter	Section 30(3)	\$10.00
Park overnight between November 1 and March 31	Section 7(15)	\$30.00
Park in prohibited zone	Section 11(1)	\$30.00
Park on sidewalks	Section 7(5)	\$30.00
Park longer than permitted	Section 30(5)	\$30.00

5. That this by-law comes into effect upon being passed.
