IN THE ONTARIO MUNICIPAL EMPLOYEES RETIREMENT  
SYSTEM.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF  
NORTH BAY HEREBY ENACTS AS FOLLOWS:


- 1. That Section 5 of By-law No. 2066 be amended by the  
addition of:
  - (a) Board of Commissioners of Police for the City  
of North Bay
  - (b) The Parking Authority of the City of North  
Bay


and the deletion of North Bay Community Memorial  
Building Commission so that the paragraph will  
now read as follows:

- 5. The Corporation hereby elects to participate  
together with the following local boards of  
the Corporation as a single employer:
  - (a) Board of Commissioners of Police for  
the City of North Bay
  - (b) The Parking Authority of the City of  
North Bay

under The Ontario Municipal Employees Retirement  
System Act, 1961-62 and the Regulations thereunder.

READ A FIRST TIME IN OPEN COUNCIL THIS 10TH DAY OF SEPTEMBER, 1973.  
READ A SECOND TIME IN OPEN COUNCIL THIS 24TH DAY OF SEPTEMBER, 1973.  
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED  
THIS 9TH DAY OF OCTOBER , 1973.

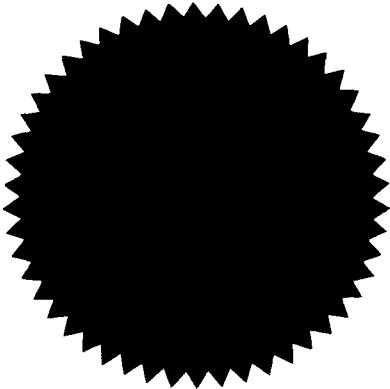
THE BOARD ORDERS that the said application be and the same is hereby granted, and that the corporation may now proceed with the purchase of the lands for the purpose of establishing an industrial subdivision described in Schedule "A" attached hereto and for such purpose may pass all requisite by-laws, provided:

1. that the sum of \$137,160.00 shall be payable out of current revenue over the years 1974 to 1978 inclusive,
2. that any by-law authorizing the said undertaking is passed by a three-fourths vote of all members of the council of the said corporation, and
3. that the corporation may borrow the whole or any part of the said sum of \$137,160.00 as

required pending receipt of subsidies or the receipt of monies from any other source.
