

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 29-95

BEING A BY-LAW TO AMEND BY-LAW NO. 131-93 (SCHEDULE 2 - NO PARKING ANYTIME; SCHEDULE 6 - PARKING PROHIBITED FOR RESTRICTED PERIODS; SCHEDULE 9 - THROUGH HIGHWAYS)

WHEREAS the Municipal Act, R.S.O., 1990, Chapter M-45, as amended, authorizes the Council to pass by-Laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-Laws regulating traffic on highways.

NOW THEREFORE THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 2 to Traffic By-Law No. 131-93 is hereby amended by adding the following:

Section M

7. Browning St.	East	Scollard & Vimy Sts.	8 a.m. to 6 p.m.
8. Browning St.	Both	Bloem & Scollard Sts.	8 a.m. to 6 p.m.
9. McLaren St.	North	Bloem St. & 142 metres easterly	8 a.m. to 6 p.m.
10. Scollard St.	South	Browning & Beattie Sts.	8 a.m. to 6 p.m.
11. Vimy St.	North	Browning & Beattie Sts.	8 a.m. to 6 p.m.




