**BY-LAW NO. 2009-97**

A BY-LAW TO AMEND BY-LAW NO. 2002-133  
(BEING A BY-LAW TO CONFIRM THE ROADS AND  
STREETS MAINTAINED BY THE CITY OF NORTH  
BAY)

WHEREAS Section 31(2) of the *Municipal Act*, S.O. 2001, as amended, authorizes a Municipality to pass a By-Law to establish a highway;

AND WHEREAS by Resolution No. 2006-482 passed on Tuesday, August 8, 2006, Council authorized the assumption of the McKeown Avenue Road Allowance;

AND WHEREAS by Resolution No. 2007-292 passed on Monday, April 30, 2007, Council authorized the assumption of the Fisher Street Road Widening;

AND WHEREAS by Resolution No. 2005-140 passed on Monday, February 28, 2005, Council authorized the assumption of Part 2, Plan 36R-12355 for road widening purposes (Galt and High Street);

AND WHEREAS by Resolution No. 2008-593 passed on Monday, September 8, 2008, Council authorized a Subdivision Agreement for Millford Development Limited for Lots on Gordon Drive, Connaught Avenue and Norman Avenue and deemed it expedient to assume Parts 42 and 43 on Plan 36R-12545 as part of the roadway;

AND WHEREAS pursuant to the provisions of a Site Plan Control Agreement entered into on the 18<sup>th</sup> day of August, 2006, with Atlas Copco Canada Inc., Part 1 was transferred to the City for the future widening of McKeown Avenue, it is deemed expedient to assume Part 1, Plan 36R-12437 as part of the roadway;

AND WHEREAS by Resolution No. 2008-73 passed on the Monday, January 21, 2008, Council authorized the assumption of the Gormanville Road Widening;

AND WHEREAS it is deemed desirable to repeal certain by-laws as a matter of form.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. By-Law 2002-133 is hereby amended by adding the attached Schedule "B".
2. By-Law No.'s 2006-159, 2007-239, 2008-09, 2008-215 and 2009-02 are hereby repealed.
3. This By-Law comes in effect upon being passed.
