

BY-LAW NO. 1991

BEING A BY-LAW of the Corporation of the City of North Bay to authorize the construction and equipping of an addition and the effecting of necessary alterations to the Dr. Carruthers Public School (McPhail Street).

WHEREAS it is deemed necessary to construct and equip an addition and effect necessary alterations to the Dr. Carruthers Public School, and


WHEREAS it is necessary to borrow for the said construction, equipping and alterations to the Dr. Carruthers Public School the sum of \$225,000.00.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. That the North Bay Public School Board be given authority to construct and equip such new addition of four (4) classrooms and a playroom and effect the necessary alterations to the Dr. Carruthers Public School subject to approval by the North Bay City Council be resolution.
2. That the North Bay Public School Board shall forthwith make such plans and specifications as may be necessary for the calling of tenders, and for the making of a contract for the execution of the work.
3. That the work shall be carried on and executed under the supervision and according to the direction of the North Bay Public School Board, or its architect.
4. That the Treasurer of the City of North Bay may, subject to the approval of the Council, agree with any bank or person for temporary advances of money to meet the cost of construction pending completion of such construction.
5. That the debentures to be issued for the loan to be effected to pay for the cost of this work, shall bear interest at such rate as the Council may determine and the debenture principal and the debenture interest be made payable within twenty years on the instalment plan as approved by the Department of Education, and under authority of the Public Schools Act, being Chapter 330, Sec. 63, R.S.O. 1960, or as amended.
6. That this by-law shall only become effective on the final passing after approval in writing has been secured from the Ontario Municipal Board by virtue of Section 64, of the Ontario Municipal Board Act, Chapter 274, R.S.O. 1960.





the City of North Bay and upon consideration of the
material filed;

THE BOARD ORDERS, under and in pursuance of the
legislation above referred to and of any and all other
powers vested in the Board, that the said application is
hereby granted; and

(a) that The North Bay Public School Board may now
proceed with the undertaking and exercise all of its powers
in connection therewith; and

(b) that the Corporation of the City of North Bay may
pass all requisite by-laws, including debenture by-laws, and
may borrow money to the extent sufficient to provide an
amount not exceeding \$225,000 for the said purpose, repay-
able over a term not exceeding twenty years.
