## BY-LAW NO. 1296

WHEREAS under order of the Ontario Municipal Board dated the 17th. day of January, 1938, the City of North Bay was divided into three wards.

AND WHEREAS it is deemed expedient to divide the said wards into the following subdivisions incompliance with the Municipal Act being R.S.O. 1937, Chapter 266, more particularly Section 83.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That Ward No. 1 of the City of North Bay as set out in the aforesaid Order of the Municipal Board shall be divided into the following sub-divisions:

Polling Sub-Division No. 1

ALL that part of the City of North Bay lying south westerly of the centre line of Jane Street between the northern boundary of the City of North Bay and the centre line of Bell Street and Eleventh Street extended to the shore of Lake Nipissing.

Polling Sub-Division No. 2

ALL that part of the City of North Bay lying south westerly of the centre line of Jane Street and between the centre lines of Bell and Harvey Streets and the centre lines of Ninth and Eleventh Streets extended to the shore of Lake Nipissing.

Polling Sub-Division No. 3

ALL that part of the City of North Bay lying south westerly of the centre line of Copeland Street between the centre line of Harvey and Ninth Streets and the centre line of Klock Avenue from Copeland to a point where Klock Avenue produced southerly intersects the shore of Lake Nipissing.

Polling Sub-Division No. 4

ALL that part of the City of North Bay bounded by and lying between the centre lines of Bloem Street and Klock Avenue to Jane Street, Jane Street from Bloem to Harvey Street, Harvey Street from Jane to Copeland Street, Copeland Street from Harvey to Klock Avenue, Klock Avenue from Copeland Street to Front Street, Front Street from Klock Avenue to Douglas Street, Douglas Street to High Street, High Street from Douglas to Klock Avenue, Klock Avenue from High Street to Bloem Street.

Polling Sub-Division No. 5

ALL that part of the City of North Bay lying north from the centre line of Bloem and High Streets to the northern boundary of the City of North Bay between the centre line of Morin Street and the western boundary of the City of North Bay including the north side of Jane Street from the intersection of the centre line of Bloem Street and Jane Street to Scollard Street and the east side of Klock Avenue between High and Bloem Streets.

Polling Sub-Division No. 6

ALL that part of the City of North Bay lying north from the centre line of Front Street to the northern boundary of the City of North Bay between the centre line of Morin Street from High Street to the boundary line and the centre line of Douglas Street from High Street to Front Street and the centre line of McPhail Street from Front Street to the City Boundary.

Polling Sub-Division No. 7

ALL that part of the City of North Bay lying north from the centre line of Cassells Street to the northern boundary of the City of North Bay between the centre line of McPhail Street to the eastern boundary of the City of North Bay.

2. That Ward No. 2 of the City of North Bay as set out in the aforesaid Order of the Municipal Board shall be divided into the following sub-divisions:

Polling Sub-Division No. 8

ALL that part of the City of North Bay lying between the centre line of Klock Avenue and the centre line of Third Avenue between the centre line of Cassells Street and the centre line of Front Street.

Polling Sub-Division No. 9

ALL that part of the City of North Bay lying between the centre line of Klock Avenue and the centre line of Third Avenue between the centre line of Cassells Street and the centre line of Fraser Street.

Polling Sub-Division No. 10

ALL that part of the City of North Bay lying between the centre line of the extension of Klock Avenue and the centre line of Third Avenue between the centre line of Fraser Street and the centre line of Ferguson Street.

Polling Sub-Division No. 11

ALL that part of the City of North Bay lying between the centre line of the extension of Klock Avenue and Third Avenue between the centre line of Ferguson Street and the centre line of Wyld Street.

Polling Sub-Division No. 12

ALL that part of the City of North Bay lying between the centre line of Third Avenue and the centre line of Fifth Avenue between the centre line of Wyld Street and the centre line of Front Street.

Polling Sub-Division No. 13

ALL that part of the City of North Bay lying between the centre line of Fifth Avenue and the centre line of King Street between the centre line of Front Street and the centre line of Wyld Street.

Polling Sub-Division No. 14

ALL that part of the City of North Bay lying between the Centre line of Third Avenue and the centre line of Aubry Street between the centre line of Wyld Street and the centre line of Fisher Street.

Polling Sub-Division No. 15

ALL that part of the City of North Bay lying between the centre line of King Street and the eastern boundary of the City of North Bay between the centre line of Wyld Street from the centre line of King Street to the centre line of Aubry Street, Fisher Street from the centre line of Aubry Street to the northern boundary of the T. & N. O.

Railway along the northern boundary of the T. & N. O. Railway from the centre line of Fisher Street to the eastern boundary of the City of North Bay and the centre line of Cassells Street from the centre line of King Street to the eastern boundary of the City of North Bay including the east side of Aubry Street between Wyld and Fisher Streets.

That Ward No. 3 of the City of North Bay be set out in the aforesaid order of the Municipal Board shall be divided into the following sub-divisions:

Polling Sub-Division No. 16

ALL that part of the City of North Bay lying between the centre line of Third Avenue and the centre line of McIntyre Street between the centre line of Wyld Street and the centre line of Fisher Street.

Polling Sub-Division No. 17

ALL that part of the City of North Bay lying between the centre line of Third Avenue and the centre line of McIntyre Street between the centre line of Fisher Street and the centre line of John Street.

Polling Sub-Division No. 18

ALL that part of the City of North Bay lying between the centre line of McIntyre Street and the Lake Shore between the centre line of Wyld Street extended to intersect with the extension of the centre line of Klock Avenue and the centre line of Regina Street from Oak Street to the Lake Shore and John Street from the centre line of Oak Street to the centre line of McIntyre Street including the east side of Oak Street between Regina and John Streets.

Polling Sub-Division No. 19

ALL that part of the City of North Bay lying between Mc-Intyre Street from the centre line of John Street to the centre line of Metcalfe Street and the Lake Shore and between the western boundary of the C.P. Railway property from the centre line of Metcalfe Street and the Lake Shore between the southern boundary of the City of North Bay and the centre line of Regina Street from the centre line of Oak Street to the Lake Shore including the west side of Oak Street from Regina to John and the South side of John St. between McIntyre and Oak Streets.

POLLING Sub-Division No. 20

ALL that part of the City of North Bay lying between the centre line of Third Avenue extended to the southern boundary of the City of North Bay and the western boundary of the C.P. Railway property between the centre line of John Street from Third Avenue to McIntyre Street, the centre line of Metcalfe Street from McIntyre Street to western boundary of the C.P.R. property and the southern boundary of the City of North Bay including the east side of McIntyre Street between John and Metcalfe Streets.

Polling Sub-Division No. 21

All that part of the City of North Bay lying between the centre line of Third Avenue and the centre line of Laurier Avenue between the centre line of Fisher Street and the northern boundary of the T. & N. O. Right-of-way.

Polling Sub-Division No. 22

All that part of the City of North Bay between the centre line of Third Avenue extended to the southern boundary of the City of North Bay, the centre line of Laurier Avenue and the eastern boundary of the City of North Bay between the southern boundary of the City of North Bay and the centre line of Fisher Street to the northern boundary of the T. & N. O. Railway and along the T. & N. O. Railway to the eastern boundary of the City of North Bay and between the southern boundary of the City of North Bay and the northern boundary of the T. & N. O. Railway from the centre line of Laurier Avenue to the centre line of Third Avenue.
