

BY-LAW NO. 2070

BEING A BY-LAW to amend By-law No. 1896, a by-law to regulate traffic within the limits of the City of North Bay.

WHEREAS it is deemed necessary to amend said By-law No. 1896.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. THAT Section Ten be inserted to read as follows:
 - (1) Highways set out in Schedule "L" to this by-law are hereby designated as "Truck Routes".
 - (2) No "heavy traffic" shall be operated on any highway in the City of North Bay other than on the highways set out in Schedule "L" hereto.
