

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2424

Being a By-law to expropriate the lands and premises hereinafter more particularly described for highway purposes.

WHEREAS it is necessary to expropriate the lands and premises hereinafter more particularly described for the purpose of constructing and maintaining a highway;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the lands and premises hereinafter more particularly described be expropriated and taken for the purpose of constructing and maintaining a highway over the said lands or portions thereof.

DESCRIPTION OF LANDS AND PREMISES

All and Singular those certain parcels or tracts of lands and premises situate, lying and being in the City of North Bay in the District of Nipissing and Province of Ontario, being composed of all of Lots 12, 14 to 21 (both inclusive), 31 to 33 (both inclusive) and part of Lots 23 and 25 to 30 (both inclusive) as shown on Registered Plan No. 27 for the City of North Bay registered in the Registry Office for the Registry Division of the District of Nipissing and all of Lots 1, 2, 3, 13, 17, 18, 19, 20, 21 and 27 and part of Lots 16, 26 and 28 as shown on Registered Plan No. 47 for the City of North Bay registered in the Registry Office for the Registry Division of the District of Nipissing, all of which said Lots and parts of Lots are shown and designated as Parts 1 to 29 (both inclusive) on Plan NRD-1563 dated the 15th day of September 1967 made by D. J. Macdonell, O.L.S., and which said Plan is attached hereto and marked Schedule "A" to this By-law.

2. That the Mayor and Clerk of The Corporation of the City of North Bay be and they are hereby authorized and empowered to execute the within By-law on behalf of The Corporation of the City of North Bay and to sign the attached Plan NRD-1563 marked Schedule "A" to this By-law including the linen copy thereof to be registered in the Registry Office for the Registry Division of the District of Nipissing, North Bay, Ontario, as required by Section 4 of The Expropriation Procedures Act, 1962-63 as amended.
