THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 145-88

BEING A BY-LAW TO REVISE THE REMUNERATION AND EXPENSE ALLOWANCES OF THE ALDERMEN OF THE CITY OF NORTH BAY AND TO REPEAL BY-LAW NO. 123-78

WHEREAS pursuant to the provisions of The Municipal Act, R.S.O. 1980, Chapter 302, Sections 238 and 239, the Council of the Corporation of the City of North Bay deems it advisable to revise the remuneration and expense allowances payable to the Aldermen as aforesaid.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. a) That each Alderman of the City of North Bay be paid a remuneration of \$7,500.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his/her duties as a member of the Council.
 - b) That in addition to the annual remuneration payable to him/her as Alderman, the Deputy Mayor shall receive an additional allowance of \$1,932.00, of which one-third shall be deemed to be for expenses incident to the discharge of his duties.
- 2. That in the event that an Alderman is absent in any year from more than five (5) regularly called meetings of Council or of Council in Committee, the sum of \$30.00 shall be deducted from the salary of such Alderman for each such meeting in excess of five (5); provided that such sum shall not be deducted in the case of an Alderman being absent from a meeting by reason of being required to attend elsewhere in the business of the City if such absence is authorized by a resolution of Council.
- 3. That the expense allowance herein set out shall be the only expenses to be allowed or paid to or for any Alderman other than travelling expenses allowable pursuant to By-Law.
- 4. That the allowance herein set out shall be paid monthly not in advance.
- 5. That Clause 1(a) of this By-Law shall come into force upon the date on which the 1989-90-91 Council takes office and the balance of the By-Law shall come into force upon the final passing thereof.
- 6. That the Treasurer is hereby authorized to make adjustments to the remuneration and expenense allowances being paid to the Aldermen, except the additional allowance being paid to the Deputy Mayor as set out in Clause 1(b), such adjustments to be calculated on the percentage change in the Consumer Price Index for December of each year.
- That By-Law No. 123-78 is hereby repealed.
