THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 129-84

BEING A BY-LAW TO STOP UP, CLOSE AND SELL AN ORIGINAL LAKESHORE ROAD ALLOWANCE ALONG TROUT LAKE. (DUGAS BAY)

WHEREAS the Council of The Corporation of the City of North Bay deems it desirable to close up and sell part of an original Lakeshore Road allowance along the shores of Dugas Bay on Trout Lake;

AND WHEREAS Section 298 (1) of the Municipal Act, R.S.O. 1980, Chapter 302, authorizes the Council to pass by-laws to stop up and sell the freehold of a highway, provided that the by-law does not take effect until it has been approved by the Minister of Municipal Affairs and Housing;

AND WHEREAS notice of this by-law has been published at least once a week for four successive weeks and the Council has heard any person who claims that his land will be prejudicially affected by this by-law and who has applied to be heard.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That certain part of a highway being the original Lakeshore Road allowance along the shores of Dugas Bay on Trout Lake designated as Parts 1 to 8 inclusive according to a Reference Plan prepared by P.A. Blackburn, O.L.S., dated March 2, 1983 is hereby stopped up and closed.
- 2. The Corporation of the City of North Bay is hereby authorized and directed to sell the soil and freehold of that part of the said original lakeshore road allowance designated as Parts 1 to 8, inclusive on the said reference plan as follows:
 - (a) Part 1 to Marie Claire Holman, registered owner of Parcel 900 W & F
 - (b) Part 2 to Theodore Vaillancourt, Barbara Vaillancourt and Theresa Vaillancourt, registered owners of Parcel 10650 W & F
 - (c) Part 3 to Mary Agnes Dugas, registered owner of Parcel 2735 W & F
 - (d) Part 4 to Dorothy May Lucenti and Mary Agnes Dugas, registered owners of Parcel 5847 W & F
 - (e) Part 5 to Dorothy Lucenti, registered owner of Parcel 2682 W & F
 - (f) Part 6 to John Kenneth Larden and Barbara Elizabeth Larden the registered owners of Parcel 5119 W & F
 - (g) Part 7 to M. Frances Bell, registered owner of Parcel 3013 W & F
 - (h) Part 8 to Allan William Larden and Charlotte Elizabeth Larden, registered owners of Parcel 5523 W & F
- 3. The Mayor and Clerk are hereby authorized and directed to execute transfers in favour of the registered owners of land as referred to in Section 2 of this by-law.

 This by-law does not take effect until it has been approved by the Minister of Municipal Affairs and Housing.
