

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 159-81

BEING A BY-LAW TO AMEND BY-LAW NO. 9-69
OF THE CITY OF NORTH BAY PURSUANT TO
SECTION 39 OF THE PLANNING ACT R.S.O.
1980, CHAPTER 379

WHEREAS upon the request of the property owner concerned and with the approval of the local Planning Board, it is considered advisable to amend By-law No. 9-69 to provide for an alteration to the zone designation as shown on Schedule "A" which forms part of said By-law No. 9-69.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Schedule "A" of By-law No. 9-69 is amended by changing the zoning designation of the land shown on Schedule "A" attached hereto and forming part hereof, which property is more particularly described as Lot 165 and Part of Lot 164 Plan M-28 in the City of North Bay from "Residential Second Density (R.2)" Zone to a "Residential Third Density (R.3)" Zone as shown on Schedule "B" attached hereto and forming part hereof.
2. All buildings or structures erected or altered and the use of land in such "Residential Third Density (R.3)" Zone hereby established shall conform to all applicable provisions of By-law No. 9-69 except as hereby expressly varied.
3. (a) Notice of this By-law shall be given in the manner and form and to the persons prescribed by Ontario Regulation 78/80.
(b) Where no notice of objection is filed with the Clerk of The Corporation of the City of North Bay within twenty-one (21) days of service of the notice as prescribed by Ontario Regulation 78/80, then this By-law thereupon comes into force and effect.
(c) Where notice of objection is filed with the Clerk of The Corporation of the City of North Bay within twenty-one (21) days of service as prescribed by

Ontario Regulation 78/80 this By-law shall
come into force and effect upon the approval
of The Ontario Municipal Board.




