

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 121-73

BEING A BY-LAW PASSED PURSUANT TO THE PROVISIONS OF THE LOCAL IMPROVEMENT ACT, R.S.O. 1970, CH. 223, SECTION 8, DECLARING IT IS DESIRABLE THAT THE CONSTRUCTION OF SANITARY SEWERS AND SERVICE CONNECTIONS AS DESCRIBED IN SCHEDULE "A" TO THIS BY-LAW SHOULD BE UNDERTAKEN AS A LOCAL IMPROVEMENT.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

Pursuant to the provisions of The Local Improvement Act, R.S.O. 1970, Chapter 223, Section 8 it is hereby declared it is desirable that the construction of sanitary sewers and service connections as described in Schedule "A" to this by-law should be undertaken as a local improvement.

READ A SECOND TIME IN OPEN COUNCIL THIS 19TH DAY OF NOVEMBER 1973
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 19TH DAY OF NOVEMBER, 1973.

A 8" sanitary sewer and service laterals on Circle Lake Road from
Wallace Road to 390 feet East of Wallace Road

An 18" diameter sanitary sewer and service laterals on Airport
Road, from O'Brien Street to Bennett Street and on Bennett Street
from Airport Road to 250 feet South of Airport Road.

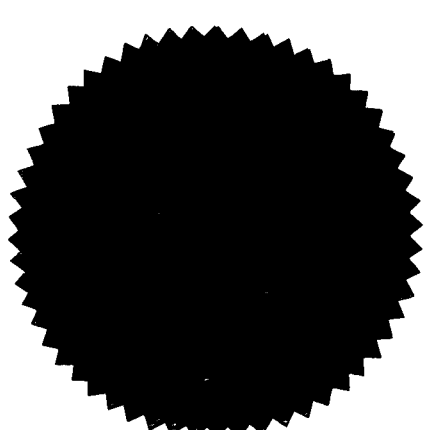
