This fund is for **Projects** only, Events will not be evaluated.

## Purpose

This Fund is for community projects aimed to celebrate the City of North Bay's 100th Anniversary and leave a lasting impact on the community.

## Fund Information

This Fund will cover up to a maximum of \$10,000. Successful applicants will receive 50% up front and 50% upon project completion.

## What is a Legacy Project?

Projects can be defined as something that is a permanent fixture or that will leave a lasting impact to be viewed/enjoyed by the community and must be open to the public.

Some examples include;

- Murals/permanent art installations
- Signage/Plaque(s)
- Trail Improvements
- Community Garden, etc.)
- Historical Book

## What is not considered a Legacy Project?

- One time events
- Improvements to personal property without intent to celebrate North Bay's Centennial
- Projects that are not sustainable/Centennial focused
- Projects that are not open to the public
- Projects that have very little reach/impact on the community

## Important Information

- With a limited amount of funds, not all applicants will be successful
- Upon acceptance, all successful applicants will need to fill out a Centennial Logo Request form to apply the Centennial logo to their project advertising
- All successful applicants are required to complete a final report upon project completion
- Applications will be Juried by the Centennial Legacy Projects Sub-Committee
- The City of North Bay must be listed as a supporter in all advertising and promotional materials relative to the amount provided along with the Centennial Logo
