

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 10-90

BEING A BY-LAW TO STOP UP AND CLOSE A PORTION
OF A LANEWAY BETWEEN FROST AVENUE AND CARRUTHERS
STREET AND A PART OF HARRISON STREET.

WHEREAS it is deemed expedient and in the interest of The Corporation of the City of North Bay that part of the laneway hereinafter described be closed and stopped up and part of Harrison Street in the City of North Bay be closed and stopped up.

AND WHEREAS notice of this By-Law was published once a week for four consecutive weeks in the North Bay Nugget, published in the City of North Bay;

AND WHEREAS no person has claimed that his lands will be prejudicially affected by the passing of this By-Law nor applied to be heard in person or by his counsel, solicitor or agent, by the Council of the said City or a Committee of said Council;

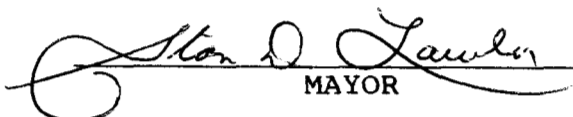
NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That part of Harrison Street shown as Part 26 on Plan 36R-5909 abutting Parts 11 and 23, Plan 36R-5909 in the City of North Bay is hereby closed and stopped up.
2. Those parts of a laneway between Frost Avenue and Carruthers Street abutting Lots 1769, 2304 to 2316 and 2324, Plan M-177 and Parts 11 and 23, Plan 36R-5909 in the city of North Bay shown as Parts 1, 2 and 3 on a Plan of Reference prepared by P.A. Blackburn Limited, O.L.S., dated December 20, 1989, are hereby closed and stopped up.
3. The City shall transfer Part 26 on Plan 36R-5909, Parts 11 and 23, Plan 36R-5909 and Parts 1, 2 and 3 on a Plan of Reference prepared by P.A. Blackburn Limited, O.L.S. dated December 20, 1989 to the owners of the lands abutting thereon, their successors or assigns, upon receipt of the consent in writing of the abutting registered owner, if the Transfer is to be a person other than the abutting registered owner.
4. This By-Law comes into force and effect upon a certified copy of this By-Law being registered in the Land Registry Office for the District of Nipissing.

READ A SECOND TIME IN OPEN COUNCIL THE 5TH DAY OF FEBRUARY 1990.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS
