## BY-LAW NO. 80 - 95

## A BY-LAW TO AUTHORIZE THE TRANSFER OF THE LANDS TO NORTH BAY GENERAL HOSPITAL (750 SCOLLARD STREET)

WHEREAS on February 13, 1984 the Council of The Corporation of the City of North Bay approved in principle the formation of a single hospital corporation to construct and operate one hospital, representing a combination of St. Joseph's General Hospital and the North Bay Civic Hospital;

AND WHEREAS the Council has agreed to turn over the North Bay Civic Hospital lands to the North Bay General Hospital pursuant to The City of North Bay Act, 1986;

AND WHEREAS the North Bay General Hospital is the successor by amended Letters Patent to the North Bay & District Health Centre Inc, as an independent public hospital;

AND WHEREAS St. Joseph's General Hospital has been turned over to North Bay General Hospital;

AND WHEREAS the Municipality is authorized by section 191 of the Municipal Act, R.S.O. 1990, Chapter M-45, to dispose of lands no longer required for municipal purposes.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- The Corporation of the City of North Bay is hereby authorized and directed to transfer the lands described in Schedule "A" attached hereto to North Bay General Hospital upon payment of the sum of \$1.00.
- 2. The Mayor and Clerk are hereby authorized and directed to execute the said transfer and such further and other documents as may be reasonably required to complete the transfer of the said lands.
