

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 143-91

BEING A BY-LAW TO RENAME THE STREETS AND
ROADS WITHIN THE CITY OF NORTH BAY

WHEREAS Council may name streets within the City of North Bay pursuant to Section 210 (105) of the Municipal Act;

AND WHEREAS it is deemed desirable to assign or change the names of several streets and roads in the City of North Bay;

AND WHEREAS before passage of this By-law, notice of same was published at least once a week for four (4) successive weeks in a newspaper having general circulation in the City of North Bay;

AND WHEREAS before passage of this By-law the Council of the City of North Bay shall hear any person who claims that he will be adversely affected by the By-law and who applies to be heard.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1) The name of Davis Drive (between Parts 1 and 2, Plan 36R-7233 and Parts 3 and 4, Plan 36R-7232, municipal numbers 155 to 159 on Massey Drive) is hereby changed to "Oriole Crescent".
- 2) The name of McNabb Crescent (abutting Parts 1 and 2, 36R-3727, Lots 29 to 32 and Lots 39 to 44, Plan M-366 and Parts 1 and 2, Plan 36R-3727, municipal numbers from 373 to 399 and from 350 to 398) is hereby changed to "Gordon Drive".
- 3) The highway running northerly from Four Mile Lake Road to Four Mile Lake in Lot 12, Concession II (abutting Parcels 5118, 3884 and 2294 W & F and Part 1, Plan NR-1627) is hereby named "Hurtubise Road".
- 4) The highway running southerly from the "B" Line Road in Lot 20, Concession B (abutting Parts 1, 2 and 3, Plan NR-1977 and Parcel 7701 W & F) is hereby named "Plue Road".
- 5) The new road names shall be affixed to sign posts located at the corners of such street in place of the previous name signs.



READ A FIRST TIME IN OPEN COUNCIL THE 8TH DAY OF JULY 1991.


READ A SECOND TIME IN OPEN COUNCIL THE 28TH DAY OF OCTOBER 1991.
