BY-LAW NUMBER 888.

BEING A BY-LAW to provide for the appointment of a Veterinary Inspector and to outline his duties.

WHEREAS it is deemed expedient to appoint a Veterinary Inspector for the Municipality of the City of North Bay and to define his duties.

THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. There shall be appointed a Veterinary Inspector for the Municipality of the City of North Bay whose duties shall be as follows:
- (a) To make periodical inspection of all premises, locally and in vicinity and cattle of all milk producers supplying milk or milk products intended for sale, for human consumption, within the Municipality of the City of North Bay.
- (b) To make quarterly veterinary inspection of all producing cattle from whom milk is intended for sale within the City of North Bay, and any further cattle that said producing cattle may come in contact with situate on the same premises.
- test necessary, for the detection of disease in herds, from which milk is offered for sale within the City of North Bay, and should any reaction be noted in any animal or animals in the above herds, to have the infected animal or animals segregated, and the matter duly reported to the Veterinary Director General, for his attention and action, as required by the Veterinary Act. All matters pertaining to the slaughter of animals so infected to be left to the discretion of the Veterinary Director General for his advice. Such animals to be kept so segregated until their condition is settled.
 - (d) To inspect all milk houses, stables, sheds and other buildings used in connection with the production or handling of milk or milk products so as to insure their being kept clean and sanitary with impermeable floors and proper drainage.
 - (e) To make periodical inspection of all meats and premises where meats are offered for sale within the City of North Bay.
 - (f) To assist in the enforcement of the terms of the provisions of the Pasteurization By-law of the City of North Bay and to report any infractions of said By-Law for proper action thereon.
 - To make periodical tests from initial samples taken at random of all milk that is intended for sale within the City of North Bay for Bacteria count, butter fat and other conditions affecting the value of said products. Said tests to be made in conjunction with the Provincial Health Laboratory at North Bay.

- (h) It be compulsory, upon the owners of Milch Cows within the City Limits who use Milk for private consumption, to have a Tuberculin test of said cows made semi-annually by said Veterinary Inspector.
- 2. The said Inspector shall work in conjunction with and shall be subject to instructions from the Medical Officer of Health for the City of North Bay.
- 3. A. L. Rooks shall be and is hereby appointed Veterinary Inspector for the City of North Bay.
- 4. Said Inspector shall be paid an annual salary of \$900.00 payable in quarterly instalments of \$225.00 each.
- 5. This By-law shall take effect on the date of the passing thereof.
