BY-LAW NO. 191-90

BEING A BY-LAW TO AMEND BY-LAW NO. 91-90  
BEING A BY-LAW TO AUTHORIZE CONSTRUCTION  
OF STORM SEWERS FROM CHIPPEWA CREEK NEAR  
FRASER STREET ALONG OLIVE STREET RIGHT-OF-WAY  
IN THE CITY OF NORTH BAY AND TO IMPOSE A  
SPECIAL RATE.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY  
HEREBY ENACTS AS FOLLOWS:

1. That By-Law No. 91-90 be amended by deleting Schedule "A" attached thereto and inserting in lieu thereof Schedule "A" attached hereto and forming part of this By-Law.
2. That Clause 9 of By-Law No. 91-90 be amended by deleting the figure \$61,000.00 in the last line and inserting in lieu thereof the figure \$57,200.00.
3. That Clause 10 of By-Law No. 91-90 be amended by deleting the figure \$61,400.00 in line five thereof and inserting in lieu thereof the figure \$57,200.00.
4. That this By-Law shall not become effective until approval in writing has been secured from the Ontario Municipal Board, pursuant to Section 64(1) of The Ontario Municipal Board Act, R.S.O. 1980, Chapter 347.

READ A FIRST TIME IN OPEN COUNCIL THE 1ST DAY OF OCTOBER, 1990.

READ A SECOND TIME IN OPEN COUNCIL THE 1ST DAY OF OCTOBER, 1990.

READ A THIRD TIME IN OPEN COUNCIL AND ENACTED AND PASSED THIS 18TH

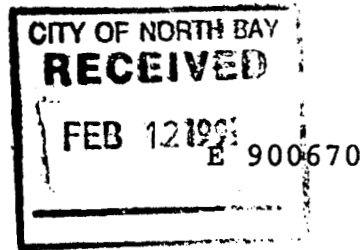



THE BOARD ORDERS that this application be granted and that the total expenditures to be incurred under this order and under the previous order of the Board with respect to O.M.B. File No. E 900670 made on the 27th day of June, 1990, and entered in order book No. E90-2 at folio 285 on the 3rd day of August, 1990, are not to exceed \$170,000.00, provided that no part of the present additional expenditure of \$15,000.00 shall be debentured;

AND THE BOARD ORDERS that the said previous order with respect to O.M.B. File No. E 900670 is hereby amended by reducing the amount of the debentures approved therein by the sum of \$4,200.00 so that the total debentures to be issued for the said undertaking shall not exceed \$57,200.00 for a term not exceeding fifteen years, provided that the council of the applicant corporation in exercising any power approved by this order shall comply and conform with all statutory and other legal requirements related thereto.
