BEING A BY-LAW AUTHORIZING THE EXECUTION OF THAT CERTAIN AGREEMENT DATED THE 1ST DAY OF FEBRUARY, 1968, BETWEEN BEATRICE KELLY, OF THE CITY OF NORTH BAY, AND THE CORPORATION OF THE CITY OF NORTH BAY, PERTAINING TO AN ENCROACHMENT OF THE BUILDING SITUATE ON THE NORTH-EASTERLY ONE-HALF OF LOT NO. 155, ON THE SOUTHERLY SIDE OF MCINTYRE STREET, AS SHOWN ON REGISTERED PLAN NO. 10, FOR THE CITY OF NORTH BAY.

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. THAT the Corporation of the City of North Bay do enter into the Agreement dated the 1st day of February 1968 between Beatrice Kelly, of the City of North Bay, in the District of Nipissing, Widow, and The Corporation of the City of North Bay (a copy of which said Agreement is attached hereto and marked Schedule "A", to this By-law), upon and subject to the terms and conditions therein set forth.
- 2. THAT the Mayor and Clerk be, and they are hereby, authorized and empowered to execute the aforesaid Agreement dated the 1st day of February 1968, on behalf of The Corporation of the City of North Bay, and to affix thereto the corporate seal.

whereas the said Beatrice Kelly is the owner of a dwelling house known municipally as 388 Fisher Street and 391 McIntyre Street in the City of North Bay, and the Corporation of the City of North Bay is the owner of the land adjoining thereto on the cast side thereof, known as McIntyre Street;

AND WHEREAS by mistake a portion of the southeast corner of the said house was built upon and encroaches on the land of the said Corporation of the City of North Bay known as NoIntyro Street;

NOW THEREFORM It is agreed between the parties hereto as

the dwelling house of the said Beatrice Kelly built on lands described in Schedule "A" hereto annexed shall be deemed to have been made, and the continuance hereafter of the said encroachment shall be deemed to be, with the express licence and consent of the said Corporation of the City of North Bay, to the intent that the said Beatrice Kelly shall not acquire any easement or right in respect thereof; the aforesaid encroachment is shown on the Plan of Survey dated Jan.

30/68, made by D.J. MacDonnell, O.L.S., attached hereto and marked Schedule "B".

The said Beatrice Kelly agrees that should the dwelling be razed, removed or destroyed, the said wall, so far as it omoroaches upon the said McIntyre Street, shall not be rebuilt on the said street and the licence and consent to occupy that portion of McIntyre Street now occupied by the said dwelling house shall be terminated;

3.- This Agreement shall enure to the benefit of and be birding upon the heirs, executors, administrators, successors and assigns of the parties hereto, respectively.
