

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 90-69

BEING A BY-LAW AUTHORIZING THE EXECUTION OF A TRANSFER TO THE BOARD OF TRUSTEES OF OMOND MEMORIAL UNITED CHURCH OF PROPERTY IN THE CITY OF NORTH BAY BEING PART OF A LANE ADJACENT TO THE REARS OF LOTS 1455 TO 1460 INCLUSIVE AND LOTS 1488 TO 1499 INCLUSIVE AS SHOWN ON PLAN M-177 REGISTERED IN THE OFFICE OF LAND TITLES AT NORTH BAY.

WHEREAS the Board of Trustees of Omond Memorial United Church made application to amend or alter a portion of Plan M-177 filed in the Office of Land Titles at North Bay, Ontario, pursuant to Section 162 of The Land Titles Act, R.S.O., 1960, Chapter 204, as amended, and The Surveys Act, R.S.O. 1960, Chapter 390;

AND WHEREAS by Order of His Honour Judge F.L. Gratton made on June 27th, 1969, it was ordered that Plan M-177 be altered or amended by stopping up and closing the lane hereinafter particularly described; and it was further ordered that the Corporation of the City of North Bay shall execute a conveyance of the said lands to the Board of Trustees of Omond Memorial United Church.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. THAT the Corporation of the City of North Bay transfer to the Board of Trustees of Omond Memorial United Church the land described as follows:

"In the City of North Bay, in the District of Nipissing, being Part of Lane adjacent to the rears of Lots 1455 to 1460 inclusive and Lots 1488 to 1499 inclusive as shown on Plan M-177 registered in the Office of Land Titles at North Bay and being designated as Part 1 of a Plan of Survey of Record at the said Office of Land Titles as N.R.754".

2. That the Mayor and Clerk be and they are hereby authorized and empowered to execute on behalf of The Corporation of the City of North Bay the necessary Transfer of the said lands to the Board of Trustees of Omond Memorial United Church.
