BEING A BY-LAW for licensing and regulating houses, ordinaries, and houses where fruit, fish, oysters, clams or victuals are sold to be eaten therein, and places, not being a Standard Hotel licensed under the Liquor Control Act, for the lodging, refreshment or entertainment of the Public.

WHEREAS it is deemed advisable that a By-Law should be passed for the purpose of licensing and regulating all victualling houses, ordinaries, and houses where fruit, fish, oysters, clams or victuals are sold to be eaten therein, and places, not being a Standard Hotel licensed under the Liquor Control Act, for lodging, reception, refreshment or entertainment of the Public.

THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- l. From and after the passing of this By-Law no victualling houses ordinaries, and houses where fruit, fish, oysters, clams and victuals are sold to be eaten therein, and places, not being a standard Hotel licensed under the Liquor Control Act for the lodging, reception, refreshment or entertainment of the Public, shall be maintained within the Municipal Corporation of the City of North Bay, without the owner or proprietor first having obtained a license.
- 2. That every application for license under this By-Law shall be by Petition in writing to the Council, and upon receipt of such Petition the Chief of Police of the said City of North Bay shall, without unnecessary delay, make full inspection and inquiry and endorse thereon his report, and present same to the Council for action.
- 3. The license fee which shall be paid at the time of the filing of the application therefore shall be for each such place for the reception, refreshment or entertainment of the public, other than a Standard Hotel.
- (a) When the seating accommodation is not for more than 50 persons-- \$ 5.00
- (b) When there is accommodation for more than 50 persons 10.00
- (c) When there is not seating accommodation 5.00
- 4. The license as set out herein shall be purchased by the 20th. day of January in each year and shall expire on the 31st day of December of the year for which issued.
- 5. The Chief of Police or any of his Officers shall have the power to inspect all such places and the Chief of Police shall report such findings to the Council.
- 6. This By-Law shall not apply to or include Private Boarding Houses.
- 7. All persons having places for the reception, refreshment and entertainment of the Public licensed under this By-Law and maintaining lodging rooms in common with their business shall keep a register similar to that kept by a Standard Hotel.
- 8. In the event of any owner or proprietor carrying on business as above stated without first having obtained a license, the said owner or proprietor may be summoned to appear before the local Magistrate and shall incur a penalty of not less than Five Dollars (\$5.00) for each and every such infraction of this By-Law together with costs, and for each infraction of Paragraph 7 of this By-Law shall incur a penalty of not less than Ten Dollars (\$10.00) together with costs. And in the event of the costs and the amount of the fine not being paid forthwith, the said Owner or proprietor may be incarcerated in the Common Gaol of the District of Nipissing for not longer than thirty days.

That By-Laws of the said Corporation numbered 798, 802, 914, 955 and all other By-Laws inconsistent with this By-Law be and the same are hereby repealed.
