THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 20-74

BEING A BY-LAW TO AMEND BY-LAW NO. 9-69 OF THE FORMER CITY OF NORTH BAY PURSUANT TO SECTION 35 OF THE PLANNING ACT R.S.O. 1970, CHAPTER 349, AND AMENDMENTS THERETO.

WHEREAS, upon the request and approval of the Council of The Corporation of the City of North Bay, it is considered advisable to amend By-law No. 9-69 of the former City of North Bay to provide for an alteration to the zone designation shown on Schedule "A" which forms part of said By-law 9-69;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- Schedule "A" of By-law No. 9-69 of the former City of North Bay is amended by changing the zoning designation of the land shown on that part of said zoning map set out in Schedule "A" attached hereto and forming part hereof, which property is more particularly described as Part 6 of Plan NR-1441 shown as hatched on Schedule "B" attached hereto and forming part hereof, from "Industrial Class 2 Zone" (IC-2) to "Industrial Class 1 Special Zone 21-74" (IC-1 Special Zone 21-74).
- For the purposes of this Bv-law, all buildings and structures erected or altered in said "Industrial Class 1 Special Zone 21-74" (IC-1 Special Zone 21-74) shall conform to the regulations hereinafter set forth:
 - (a) Front Yard

The setback from the lot line shall be a minimum of twenty (20) feet;

(b) Side Yard

- Where the side lot line abuts a street, the setback from the said side lot line shall be a minimum of twenty (20) feet but in no case shall the setback from the centreline of the flanking street be less than fifty-three (53) feet;
- (ii) Where the side lot line abuts King's Highways Nos. 17 and 11, the setback from the said side lot line shall be a minimum of thirty (30) feet but in no case shall the setback from the centreline of King's Highways Nos. 17 and 11 be less than eighty (80) feet.
- All buildings and structures erected or altered in the "Industrial Class 1 Special Zone 21-74" (IC-1 Special Zone 21-74) hereby established shall conform to all other applicable provisions of said By-law No. 9-69 except as hereby expressly varied.
- This By-law shall take effect from the date of passing by Council and shall come into force upon the approval of the Ontario Municipal Board.

READ A SECOND TIME IN OPEN COUNCIL THIS 18TH DAY OF FEBRUARY, 1974.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 18TH DAY OF FEBRUARY, 1974.


