

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 111-92

BEING A BY-LAW TO AMEND LICENSING BY-LAW NO. 131-74 BEING A BY-LAW RESPECTING THE ISSUING OF LICENSES IN THE CITY OF NORTH BAY.

WHEREAS the Council of The Corporation of the City of North Bay deems it desirable to amend the Licensing By-Law to increase the license fee for Mobile Food Vendors.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "1" to By-Law No. 131-74 be amended to provide fees for Mobile Food Vendors as follows:

- "a) Non-powered ice cream and confectionery stands, \$100.00 per year and \$50.00 for each additional cart (no charge).
- b) Non-powered food carts serving food prepared on the vehicle, \$350.00 per year, plus \$175.00 for each additional cart.
- c) Powered vehicles serving foods prepared on the vehicle and prepackaged food, \$500.00 per year and \$250.00 for each additional vehicle."

2. That the following clauses be added to Section 12 of By-Law No. 131-74:

"1.(2) That an annual inspection be done by the North Bay Fire Department and an inspection be done by a licensed propane service depot.

(22) That a Certificate of Approval from the Medical Officer of Health be obtained."

3. That Schedule 12 to By-Law No. 131-74 be amended by adding the following clause:

"(14) No owner or operator of a Mobile Food vehicle shall operate from any other location in the central business district as defined on Schedule A attached hereto and forming part of this by-law other than in the areas designated as follows:

- 1. 200 Block, Main Street West, south side located in the Parkette.
- 2. 100 Block, Main Street West, located on the north side in the vicinity of Victoria & Grey Trust.
- 3. 100 Block, Main Street West, south side in the vicinity of the Royal Bank.
- 4. 200 Block, Main Street East, north side in the vicinity of the Gateway Cinemas.
- 5. Ferguson Street at the Post Office.
- 6. Second Avenue at Cassells Street."

4. This By-Law comes into force on January 1, 1992.

READ A SECOND TIME IN OPEN COUNCIL THE 25TH DAY OF MAY, 1992.
