

THE CORPORATION OF THE CITY OF NORTH BAYBY-LAW NO. 19-71

BEING A BY-LAW TO AMEND BY-LAW NO. 9-69
PURSUANT TO SECTION 30 OF THE PLANNING
ACT, R.S.O. 1960 AND AMENDMENTS THERETO.

WHEREAS upon the request of the property owners concerned and with the approval of The Planning Board it is considered advisable to amend Schedule "A" to By-law No. 9-69 to provide for an alteration in the boundaries as shown on the "Zoning Map", which constitutes Schedule "A" of said By-law;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. The "Zoning Map" which constitutes Schedule "A" attached to and forming part of said By-law 9-69 and which designates Lot No. 220, Registered Plan 115 as "Residential Multiple Second Density Zone (RM2)" is hereby amended to show the said lot zoned "Residential Third Density Zone (R3)".
2. This By-law shall come into full force and effect upon the final passing thereof subject to the approval of the Ontario Municipal Board.

READ A FIRST TIME IN OPEN COUNCIL THIS 1ST DAY OF MARCH, 1971.

READ A SECOND TIME IN OPEN COUNCIL THIS 1ST DAY OF MARCH, 1971.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 1ST DAY OF MARCH, 1971.

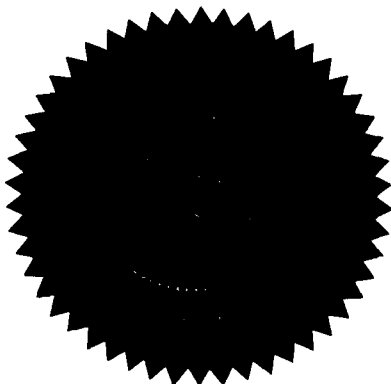
