

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 67-83

BEING A BY-LAW TO LEVY, IMPOSE AND COLLECT
A SPECIAL CHARGE FOR THE CORPORATION OF
THE CITY OF NORTH BAY ON BEHALF OF THE BOARD
OF MANAGEMENT FOR THE DOWNTOWN IMPROVEMENT
AREA.

WHEREAS pursuant to The Municipal Act, R.S.O. 1980, Chapter 302,
Section 217, as amended, The Corporation of the City of North Bay
has established a Board of Management for the Downtown Improvement
Area by By-law No. 144-77 as approved by the Ontario Municipal
Board by Order dated the 13th day of February 1978, as amended by
Order dated the 1st day of October, 1980;

AND WHEREAS Council has approved the budget submitted for the
1983 fiscal year of the Board of Management in the amount of
\$95,410. with resultant tax levy of \$88,300.;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. In this by-law,


"area", means the Downtown Improvement Area as
established by By-law No. 144-77, as approved by
Ontario Municipal Board Order dated February 1, 1978,
as amended by Order dated October 1, 1980, and more
particularly defined in Schedule "A" hereto.
2. For the purpose of providing the sum of eighty-eight
thousand, three hundred dollars (\$88,300.), for the
general purposes of the Board of Management of the
Downtown Improvement Area for its 1983 fiscal year,
there shall be levied and collected a special charge
from the persons in the area at a rate of 51.88 mills
on the business assessment of such persons to be
borne and paid by such persons in the proportion that
the assessed value of the real property that is used
as the basis for computing the business assessment
of each of such persons bears to the assessed value
for all the real property in the area used as the
basis for computing business assessment.
3. The special charge rated and imposed pursuant to the
provisions of this by-law shall become due and payable
in one instalment, namely on July 29, 1983.
4. The Tax Collector and the Treasurer of The Corporation
of the City of North Bay are hereby authorized to collect
the said special charges in the same manner and with the
same remedies as provided in The Municipal Act for the
collection of taxes upon business assessment.

SCHEDULE "A" TO BY-LAW NO. 67-83

COMMENCING at the centre line of Cassells Street
and the centreline of Oak Street;

THENCE southerly along the centreline of Oak
Street to the intersection thereof with the centre-
line of Algonquin Avenue;

THENCE northeasterly along the centreline of
Algonquin Avenue to the intersection thereof with the
centreline of Cassells Street;

THENCE westerly along the centreline of Cassells Street
to the point of commencement.
