AND THE RECREATION DIRECTOR.

WHEREAS it is considered desirable to repeal By-law
No. 2014, being a by-law to establish terms of reference
for the Recreation Committee and the Recreation Director.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF
NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. THAT effective on the 1st day of January, 1973
By-law No. 2014 is repealed.

READ A SECOND TIME IN OPEN COUNCIL THIS 16TH DAY OF OCTOBER, 1972
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND
PASSED THIS 16TH DAY OF OCTOBER, 1972.

THE BOARD ORDERS that the said application be and the same is hereby granted, and that the corporation may now proceed with the construction of the works described in Schedule "A" attached hereto at a total cost not to exceed \$46,500.00 and for such purpose may pass a by-law authorizing the said undertaking and all other requisite by-laws, including by-laws providing for the issue of debentures in a principal amount not exceeding \$46,500.00 repayable over a term of not more than twenty years and may borrow money to the extent sufficient to provide an amount not exceeding \$46,500.00 therefor, provided:

1. that the corporation may borrow the whole or any part of the said sum of \$46,500.00 as required pending receipt of subsidies and the sale of debentures or the receipt of moneys from any other source,




