BEING A BY-LAW TO AMEND BY-LAW NO. 152-89 BEING A BY-LAW TO PROVIDE THE SUM OF \$1,400,000.00 TO DEFRAY THE CITY'S PORTION OF COSTS FOR RENOVATIONS TO CASSELLHOLME, EAST NIPISSING DISTRICT HOME FOR THE AGED IN THE CITY OF NORTH BAY.

WHEREAS Council deems it desirable to amend By-Law No. 152-89 to increase the net debentured cost to \$1,700,000.00.

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY PURSUANT TO THE PROVISIONS OF THE HOMES FOR THE AGED ACT R.S.O. 1980, CHAP. 203, SEC.16, HEREBY ENACTS AS FOLLOWS;

- 1. That Clause No. 1 of By-Law No. 152-89 be amended by deleting the figure \$1,400,000.00 in line one and inserting in lieu thereof the figure \$1,700,000.00.
- 2. That Clause 6 of By-Law No. 152-89 be deleted and the following Clause be inserted in lieu thereof:
  - "(6) That this By-Law shall not become effective until approval has been received in writing from the Ontario Municipal Board, pursuant to Section 64(1) of the Ontario Municipal Board Act, R.S.O. 1980, Chapter 347."
- 3. That Schedule "A" attached to and forming part of By-Law No. 152-89 be deleted and the Schedule "A" attached hereto and forming part of this By-Law be inserted in lieu thereof.
