BY-LAW NO. 2001-104

**BEING A BY-LAW TO AMEND BY-LAW NO. 173-88, AS
AMENDED, BEING A BY-LAW TO REGULATE PARKING
ON MUNICIPAL PARKING LOTS IN THE CITY OF NORTH BAY**

WHEREAS Section 210(32) of the Municipal Act, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass by-laws for prohibiting the parking of motor vehicles on property owned or occupied by a Municipality or any local board thereof without the consent of the municipality or local board as the case may be;

AND WHEREAS Section 207(56) of the Municipal Act provides that by-laws may be passed for regulating, supervising and governing the parking of vehicles on land owned or occupied by the Municipality;

AND WHEREAS Council has passed Resolution No. 2001-473 at its meeting held July 23, 2001, approving the increase in rates in municipal parking lots;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Clause 7(a) of By-law No. 147-96 is hereby amended by deleting the clause and inserting in lieu thereof the following clause 7(a):

The Parking Manager or his authorized delegate is hereby authorized to issue permits and to reserve parking spaces for the purposes of permitting parking in the parking lots described in this by-law and to charge therefore the following sums:


Parking Lot Nos. 1, 2 ,& 3	-	\$45.00 per month
Parking Lot No. 4 (garage)		
- top two levels	-	\$45.00 per month
- inside levels	-	\$60.00 per month
Parking Lots 6, and 11	-	\$40.00 per month
Parking Lot 5	-	\$30.00 per month

2. That Schedule "B" to By-law No. 147-96 is hereby deleted and the Schedule "B" attached hereto and forming part of this by-law is inserted in lieu thereof:
3. This by-law comes into force and effect as of September 1, 2001.
