

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 195-82

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW
NO. 2-82 (SCHEDULE 2, SCHEDULE 8 AND SCHEDULE 5)

WHEREAS Council deems it desirable to provide for additional through highways comprised of part of Booth Road and part of Ferris Drive;

AND WHEREAS The Municipal Act, R.S.O. 1980, Chapter 302, as amended, authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS The Highway Traffic Act, R.S.O. 1980, chapter 198, as amended, authorizes the Council to pass by-laws regulating traffic on highways;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. (a) That Schedule 2 to Traffic By-law 2-82 be amended by adding the following to Section B:

<u>"Road</u>	<u>Side</u>	<u>Between</u>
4. Browning Street	West	Scollard Street & Vimy Street"

- (b) That Schedule 2 to Traffic By-law 2-82 be amended by adding the following to Section S:

<u>"Road</u>	<u>Side</u>	<u>Between</u>
8. Scollard Street	North	Browning Street & Beattie Street"

- (c) That Schedule 2 to Traffic By-law 2-82 be amended by adding the following to Section V:

<u>"Road</u>	<u>Side</u>	<u>Between</u>
2. Vimy Street	South	Browning Street & Beattie Street"

2. (a) That Schedule 8 to Traffic By-law No. 2-82 is hereby amended by adding the following to Section B:

<u>"Road</u>	<u>From</u>	<u>To</u>
11. Booth Road	Birch's Road	Lakeshore Drive"

- (b) That Schedule 8 to Traffic By-law No. 2-82 is hereby amended by adding the following to Section F:

<u>"Road</u>	<u>From</u>	<u>To</u>
19. Ferris Drive	Booth Road	Lakeshore Drive"

3. (a) That Schedule 5 to Traffic By-law 2-82 is hereby amended by adding the following to Section B:

<u>"Road</u>	<u>Side</u>	<u>Between</u>	<u>Prohibited</u>
1. Beattie Street	West	Scollard Street and Vimy Street	8:00 a.m. to 8:00 p.m.
2. Browning Street	East	Scollard Street and Vimy Street	8:00 a.m. to 8:00 p.m."

3. (b) That Schedule 5 to Traffic By-law 2-82 is hereby amended by adding the following to Section S:

<u>"Road</u>	<u>Side</u>	<u>Between</u>	<u>Prohibited</u>
1. Scollard Street	South	Browning Street and Beattie Street	8:00 a.m. to 8:00 p.m."


(c) That Schedule 5 to Traffic By-law 2-82 is hereby amended by adding the following to Section V:

<u>"Road</u>	<u>Side</u>	<u>Between</u>	<u>Prohibited</u>
1. Vimy Street	North	Browning Street and Beattie Street	8:00 a.m. to 8:00 p.m."
