BY-LAW NO. 52-81

BEING A BY-LAW TO AUTHORIZE THE BORROWING OF \$3,971,000 UPON DEBENTURES TOWARDS THE COST OF VARIOUS CAPITAL PROJECTS AND TO REFUND CERTAIN MATURING DEBENTURES

WHEREAS the Council of The Corporation of the City of North Bay (hereinafter called "the Corporation") has passed the by-laws enumerated in column 1 of Schedule "A" hereto authorizing the undertakings described in column 2 of said Schedule "A";

AND WHEREAS debentures in the amount of \$670,000 dated July 2, 1981 require to be refunded on July 2, 1981 under the provisions of Section 288(4) of the principal Act, R.S.O. 1970 c. 284;

AND WHEREAS the Ontario Municipal Board by its Orders issued upon the dates set forth in column 4 of Schedule "A" hereto approved the said undertakings and authorized the issue of debentures therefor in the amounts set forth in column 5 of said Schedule "A";

AND WHEREAS the Corporation desires to issue debentures for such purposes in the amounts set out in column 6 of Schedule "A" hereto;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. For the purposes aforesaid there shall be borrowed on the credit of the Corporation at large the sum of \$3,971,000, and the Corporation shall issue debentures therefor in denominations of \$1,000 and multiples thereof, to be repaid in annual instalments during the terms of years set out in column 3 of said Schedule "A".
- 2. The said debentures shall all be dated the 15th day of April, 1981, shall be issued within two years after the date on which this by-law is enacted, and as to both principal and interest shall be expressed and be payable in lawful money of Canada. The said debentures shall bear interest from the date thereof at the annual rate hereinafter set forth, which interest shall be payable semi-annually on April 15th and October 15 in each year during the currency of the said debentures.
- 3. The said debentures shall mature in various instalments of principal on April 15 in each of the years 1982 to 1996, both inclusive, as set forth in Schedule "B" hereto. The said debentures shall have coupons attached thereto for the payment of interest at the rate of fourteen and one-quarter percentum (14 1/4%) per annum.
- 4. The debentures shall be payable as to both principal and interest in lawful money of Canada at The Royal Bank of Canada in the City of North Bay or at the principal office of the said Bank in either of the cities of Toronto or Montreal, at the holder's option.
- The debentures shall be sealed with the seal of the Corporation and signed by the head of the Council or by some other person authorized by by-law to sign them and by the Treasurer. The interest coupons attached to the debentures shall be signed by the Treasurer and his signature to them may be written or engraved,

lithographed, printed or otherwise mechanically reproduced. The signature of the head of the Council on the debentures may be written or engraved, lithographed, printed or otherwise mechanically reproduced.

6. In each year during the currency of the said debentures there shall be levied and raised by a special rate sufficient therefor, over and above all other rates, on all the rateable property in the City of North Bay, the amount of the instalment of principal and interest payable in that year as set forth in Schedule "B" hereunto annexed; but no greater amount shall be raised than is required after taking into account receipts from any other sources with respect to the said undertakings.
