

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 28-73

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF THAT CERTAIN AGREEMENT DATED THE 23RD DAY OF NOVEMBER, 1972 BETWEEN THE CORPORATION OF THE CITY OF NORTH BAY, THE PARKING AUTHORITY OF THE CITY OF NORTH BAY, SOL ATLIN, HIMSWORTH INVESTMENTS LIMITED, JOHN S. HALLIDAY AND GERALD HALLIDAY RELATING TO RIGHTS-OF-WAY OVER CIVIC PARKING LOT NUMBER 4.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the Corporation of the City of North Bay do enter into that certain agreement dated the 23rd day of November, 1972 between the Corporation of the City of North Bay, The Parking Authority of the City of North Bay, Sol Atlin, Himsworth Investments Limited, John S. Halliday and Gerald Halliday relating to rights-of-way over Civic Parking Lot Number 4, upon and subject to the terms and conditions set forth in the said agreement.

2. That the Mayor and Clerk be and they are hereby authorized and empowered to execute the aforesaid agreement dated the 23rd day of November, 1972 on behalf of the Corporation of the City of North Bay and to affix thereto the corporate seal.

READ A SECOND TIME IN OPEN COUNCIL THIS 2ND DAY OF APRIL, 1973.
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 2ND DAY OF APRIL, 1973.


OFFICIAL PLAN



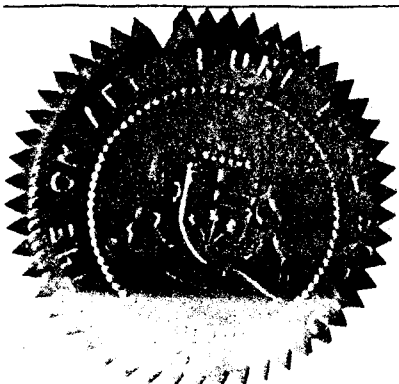


