BY-LAW NO. 123-82

BEING A BY-LAW TO AUTHORIZE THE EXPROPRIATION OF LANDS FOR THE MARSHALL AVENUE ROAD WIDENING PROJECT (JAFFRAY).

WHEREAS the Municipal Act, R.S.O. 1980, c. 302, s. 193 (1) authorizes the council to pass by-laws for expropriating any land required for the purposes of the Corporation;

AND WHEREAS Notice of an Application for Approval to expropriate certain lands for the Marshall Avenue Road Widening Project has been duly given in accordance with the Expropriations Act, R.S.O. 1980, c. 148, s. 6;

AND WHEREAS the Council has approved the proposed expropriation of Part 2, Plan 36R-5775 from June Jaffray;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. That the Certificate of Approval attached as Schedule "A" hereto be adopted by The Corporation of the City of North Bay and that the Mayor and Clerk execute the said Certificate and apply thereto the corporate seal.
- 2. That a plan of expropriation be filed on behalf of The Corporation of the City of North Bay against Part 2, Plan 36R-5775 and that the Mayor and Clerk are hereby authorized to execute the Certificate of Approval in the prescribed form on the said plan of expropriation.
- 3. That, after filing the said plan of expropriation, Notice of Expropriation in the prescribed form be given to
 - (a) the registered owner, June Jaffray or her successors, heirs or assigns as entered on the Parcel Register for Part 2, Plan 36R-5775; and
 - (b) any security holder, including the Bank of Nova Scotia.
- 4. That, after filing of the said plan of expropriation, Notice of Possession in the prescribed form be given to the registered owner of Part 2, Plan 36R-5775.
- 5. That, after filing of the said plan of expropriation, the Corporation of the City of North Bay shall pay to the registered owner and to the security holder the balance of the market value of the said lands, as their interests may appear and in accordance with the said Expropriations Act.

READ A FIRST TIME IN OPEN COUNCIL THE 28th DAY OF June , 1982.

READ A SECOND TIME IN OPEN COUNCIL THE $12th_{DAY}$ of July , 1982.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS $12th_{DAY}$ of July , 1982.
