

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 55-78

BEING A BY-LAW TO AMEND BY-LAW NO. 42-77 BEING
A BY-LAW TO AUTHORIZE THE CONSTRUCTION OF A
SANITARY SEWER SYSTEM ON CERTAIN STREES IN
THE CITY OF NORTH BAY.

WHEREAS The Council of The Corporation of the City of North Bay
authorized by Resolution No. 40 passed at its regular meeting
held Monday, 3, April, 1978 that By-law No. 42-77 be amended.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH
BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "A" to By-law No. 42-77 be amended to :
 - (a) include the construction of a 30" Diameter Sanitary Sewer along Chippewa Creek from O'Brien Street to Airport Road; and
 - (b) to increase the net cost to be debentured by \$53,000.00 so that the said Schedule "A" shall read as per Schedule "A" attached hereto and forming part of this By-law.
2. That this By-law shall not become effective until approval in writing has been secured from The Ontario Municipal Board pursuant to Section 64 (1) of The Ontario Municipal Board Act, R.S.O. 1970, Chap. 323.

READ A SECOND TIME IN OPEN COUNCIL THIS 17TH DAY OF APRIL, 1978

Construction of a 30" Diameter Sanitary Sewer from the end of the existing sewer located in boundary of Lot 440, Plan 57 to Chippewa Street; thence westerly along Chippewa Street to Chippewa Creek; thence northwesterly along Chippewa Creek to O'Brien Street; thence northerly along Chippewa Creek from O'Brien St. to Airport Road.	\$ 859,000.00

- (e) an amendment of the previous order of the Board dated the 10th day of August, 1977, by amending the description contained opposite Item 1. in the operative clause of the said previous order to include "thence northerly along Chippewa Creek from O'Brien Street to Airport Road"

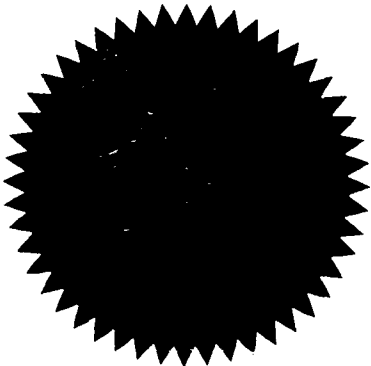
