

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 67-77

BEING A BY-LAW TO AMEND BY-LAW NO. 1896  
 BEING A BY-LAW TO REGULATE TRAFFIC IN  
 THE LIMITS OF THE CITY OF NORTH BAY.

WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to amend By-law No. 1896 of the Corporation of the City of North Bay.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "J" Part A of By-law No. 1896 be hereby amended by adding thereto the following: ("Parking Meter Zone Thirty Minute Parking Limit where Parking Meters are erected")

<u>STREET</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
Ferguson St.	West side	Worthington St.	McIntyre Str.
Worthington St.	North Side	Ferguson St.	A point approx. 107 feet west of Ferguson St. to include the first two meters west of Ferguson St.

2. That Schedule "J", Part B of By-law No. 1896 be hereby amended by adding thereto the following (Parking Meter Zone One Hour Parking Limit where Parking Meters are erected)

<u>STREET</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
McIntyre St.	Both sides	Cassells St.	Foren St.
Algonquin Ave.	EASt Side	McIntyre St.	Worthington St.

3. That Schedule "J", Part D of By-law No. 1896 be hereby amended by adding thereto the following: (Parking Meter Zone Four Hour Parking Limit where Parking Meters are erected)

<u>STREET</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
Worthington St.	North side	Cassells St.	Algonquin Ave.

4. That Schedule "J", Part E of By-law No. 1896 be hereby amended by adding thereto the following (Parking Meter Zones where Parking Meters are erected in Civic Parking Lots owned or leased by the Corporation of the City of North Bay)

PART E

4. Civic Parking Lot No. 5 on the south side of Main St. West at the intersection of Fraser St.
5. Civic Parking Lot No. 6 on the north side of Worthington Street West and known as 180 Worthington St. West
6. Civic Parking Lot No. 7 on the east side of Ferguson St. at the intersection of Worthington St. East
5. That Schedule "K", Paragraph (a) of By-law 1896 be hereby amended by adding thereto the following Parking Meter Zones: (Re Fees for Parking at Parking Meters)

6. (i) That Clause (b) of Schedule K of By-law No. 1896 be amended by adding thereto reference to clause (c) so that the said clause shall now read as follows:

(b) one nickel for each thirty minutes or fraction thereof and two nickels or one dime for each sixty minutes or fraction thereof in excess of thirty minutes for parking at a parking meter in all parking meter zones other than those set out in clauses (a) and (b) of this Schedule.

(ii) That Schedule K of By-law No. 1896 be amended by adding thereto Clause (c) to read as follows:

(c) one nickel for each twenty minutes or fraction thereof or one nickel and one dime for each sixty minutes or fraction thereof in excess of twenty minutes for parking at a parking meter located in the following parking meter zones:
