The Corporation of the City of North Bay

By-Law No. 2025-106

Being a By-Law to Amend By-Law No. 2010-108, as amended, (Waste Management By-Law – Schedule "A")

Whereas The Corporation of the City of North Bay (the "City") is the owner and operator of the Merrick Landfill Site located in Merrick Township (the "Landfill Site");

And Whereas the City is authorized to enact by-laws imposing fees or charges for services or activities provided or done by or on behalf of it pursuant to section 391 of the *Municipal Act, 2001* (S.O. 2001, c.25);

And Whereas the City is authorized to regulate and inspect the use of any land or structures within the municipality or any defined area or areas thereof for dumping or disposing of garbage, refuse, or domestic or industrial waste of any kind;

And Whereas the Council deems it desirable to regulate the disposal of garbage by way of landfill bans, recycling and home composting systems;

And Whereas Notice of the Public Meeting in the matter of waste management fees and charges was given in accordance with City of North Bay Notice By-Law 2020-79, by publishing the notice, 14 days in advance of the public meeting, in the Public Notice section of the City of North Bay's website on Wednesday, November 5, 2025.

And Whereas a Public Meeting under the *Municipal Act* in the matter of the waste management fees and charges was held on the 26th day of November, 2026;

And Whereas by General Government Committee Report No. 2025-18 passed at its Regular Meeting held on Tuesday, December 9th, 2025, Council authorized a by-law to increase the current fees and charges in place for waste management.

Now Therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

1. Schedule "A" of By-Law No. 2010-108, as amended, is hereby further amended as follows:
