

BY-LAW NO. 2169

A BY-LAW of the Corporation of the City of North Bay to authorize the construction of a new public library.

WHEREAS it is deemed necessary to purchase a site for and to erect, furnish and equip a new Public Library containing adult, children, reference, catalogue and administration sections as well as necessary utility and stack areas at an estimated cost of Three hundred and seventy-five thousand dollars (\$375,000.00.)

AND WHEREAS it is necessary to borrow for the said construction of a new Public Library building the sum of Three hundred and seventy-five thousand dollars (\$375,000.00.)

AND WHEREAS it is deemed advisable to make application to the Department of Municipal Affairs for a loan of Two hundred thousand dollars (\$200,000.00) under the Municipal Works Assistance Program.

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That the North Bay Public Library Board be given authority to purchase a site for and to erect, furnish and equip a new Public Library containing adult, children, reference, catalogue and administration sections as well as necessary utility and stack areas at an estimated cost of Three hundred and seventy-five thousand dollars (\$375,000.00.)
2. That the North Bay Public Library Board shall forthwith make such plans and specifications as may be necessary for the calling of tenders, and for the making of a contract for the erection of the work.
3. That the work shall be carried on and executed under the supervision and according to the direction of the North Bay Public Library Board, or its architect.
4. That the Treasurer of the City of North Bay may, subject to the approval of the Council agree with any bank or person for temporary advances of money to meet the cost of construction pending completion of such construction.
5. That the debentures to be issued for the loan to be effected to pay for the cost of this work, shall bear interest at such rate as the Council may determine and the debenture principal and the debenture interest be made payable within twenty years on the instalment plan.

6. That this by-law shall only become effective after approval in writing has been secured from The Ontario Municipal Board by virtue of Section 43 of the Public Libraries Act, Chapter 325, R.S.O. 1960 and by virtue of Section 64 of The Ontario Municipal Board Act, Chapter 274, R.S.O. 1960.

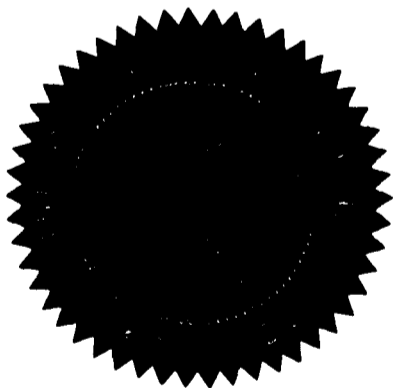

The North Bay Public Library Board may incur an additional expenditure of \$27,000 for the completion of the construction of the Public Library approved by the previous order of the Board made on the 1st day of December, 1964, and for such purpose may exercise all its powers, and that the Corporation may borrow the additional sum of \$27,000 for such purpose and may pass all requisite by-laws, including by-laws providing for the issue of debentures in a principal amount not exceeding \$27,000 repayable within the term prescribed in the said previous order, and may borrow money to the extent sufficient to provide an amount not exceeding \$27,000 therefor, provided that the said Corporation may borrow the whole or any part of the said sum of \$27,000 as required pending receipt of subsidies and the sale of debentures, or of moneys to be received from any other source.

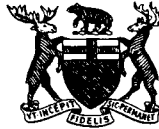

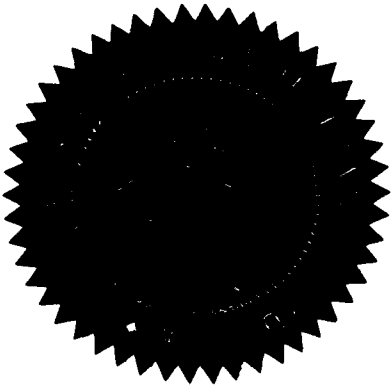

(a) that The North Bay Public Library Board may proceed with the said undertaking and exercise all of its powers in connection therewith, and

(b) that The Corporation of the City of North Bay may for such purpose pass a by-law authorizing the said undertaking and all other requisite by-laws, including by-laws providing for the issue of debentures in a principal amount not exceeding \$300,000 repayable over a term of not more than twenty years, and may borrow money to the extent sufficient to provide an amount not exceeding \$300,000 therefor; provided, however, that the amount to be debentured shall not exceed in any event the net cost to the Corporation after deducting



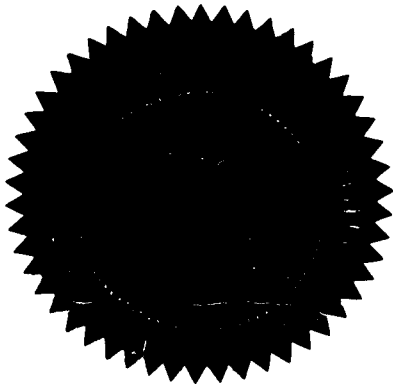
